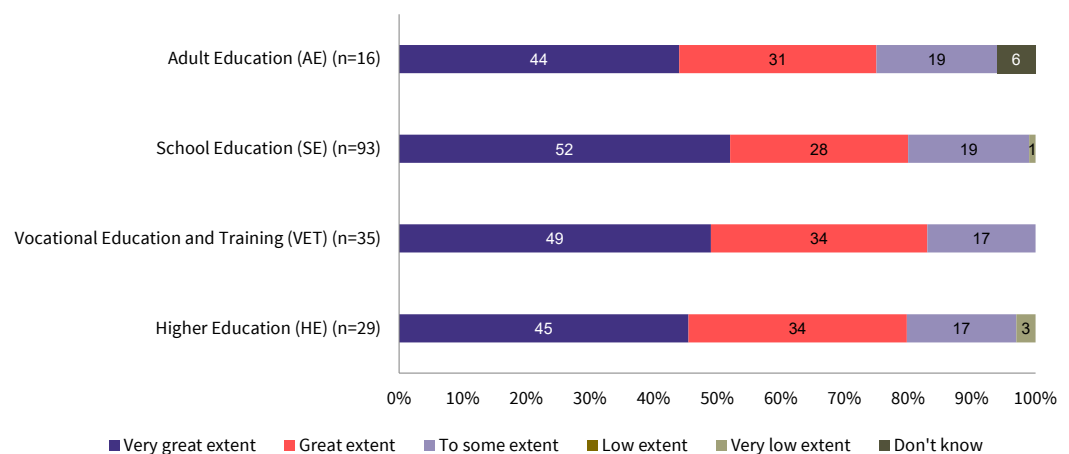

To what extent do you assess that participation in Erasmus+ has strengthened the international environment at the organisation/institution?



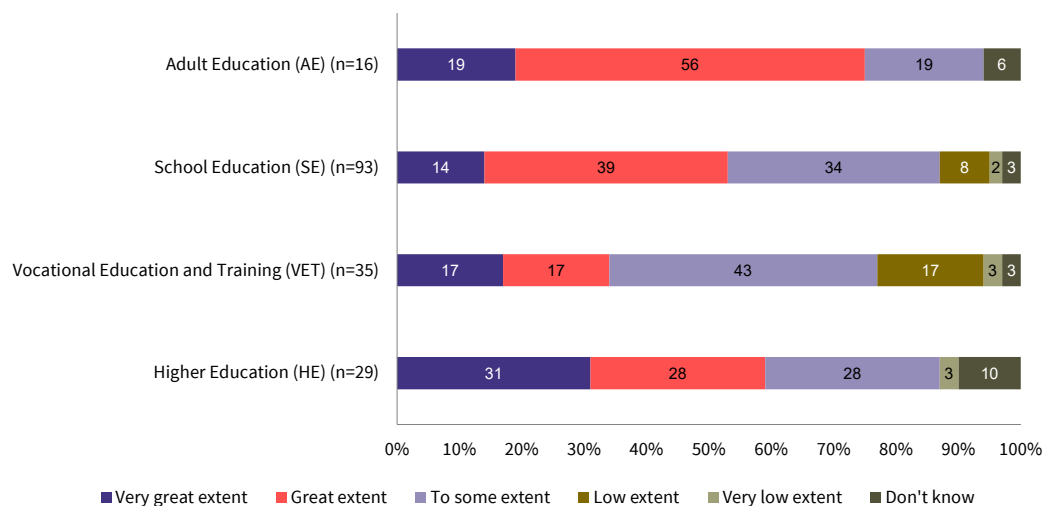

To what extent do you assess that participation in Erasmus+ has contributed with professional expertise within new subject areas?



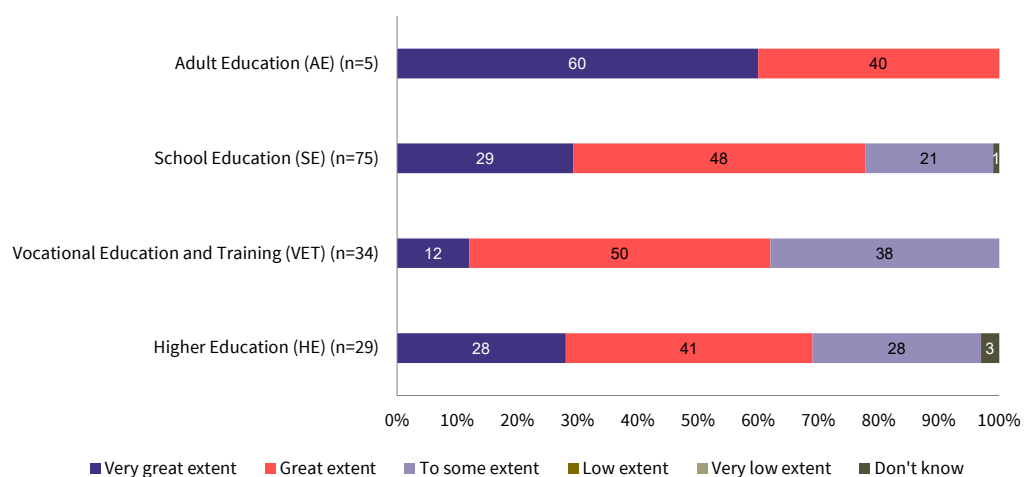

To what extent do you assess that participation in Erasmus+ has strengthened students'/pupils' professional skills?



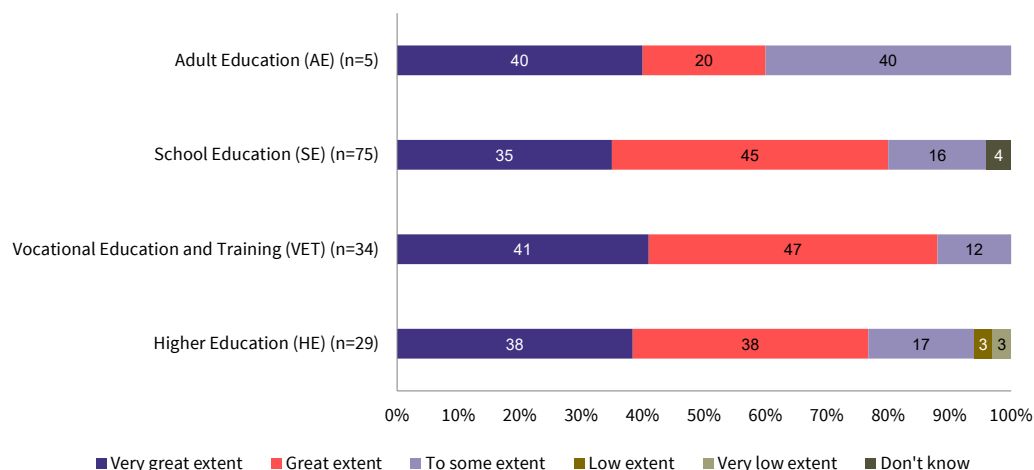

To what extent do you assess that participation in Erasmus+ has strengthened students'/pupils' study competences (independence, problem solving, etc.)?



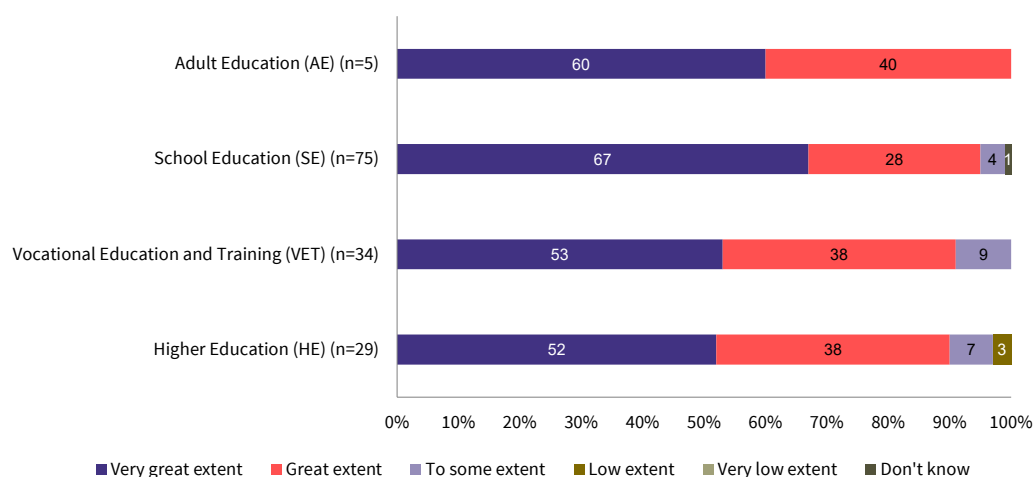

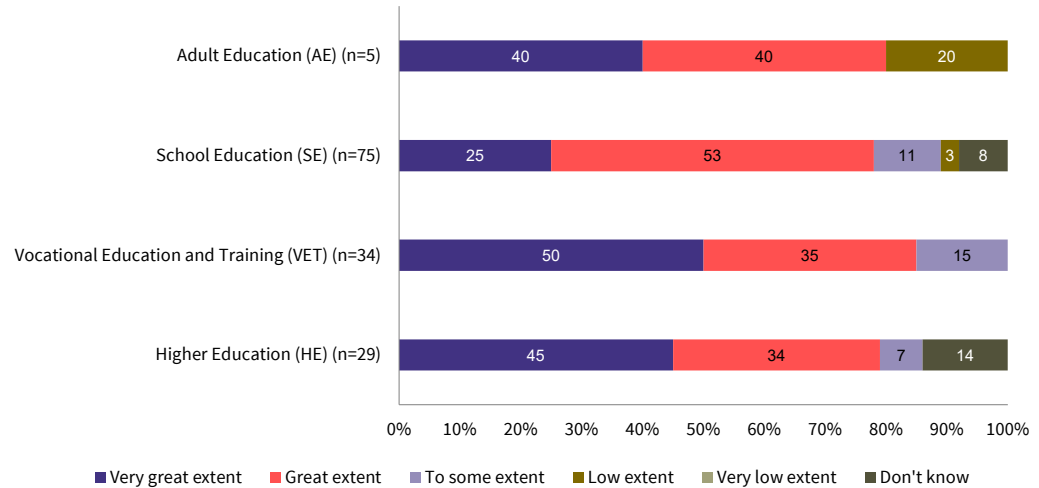

To what extent do you assess that participation in Erasmus+ gives students/pupils competences that are appreciated by employers?



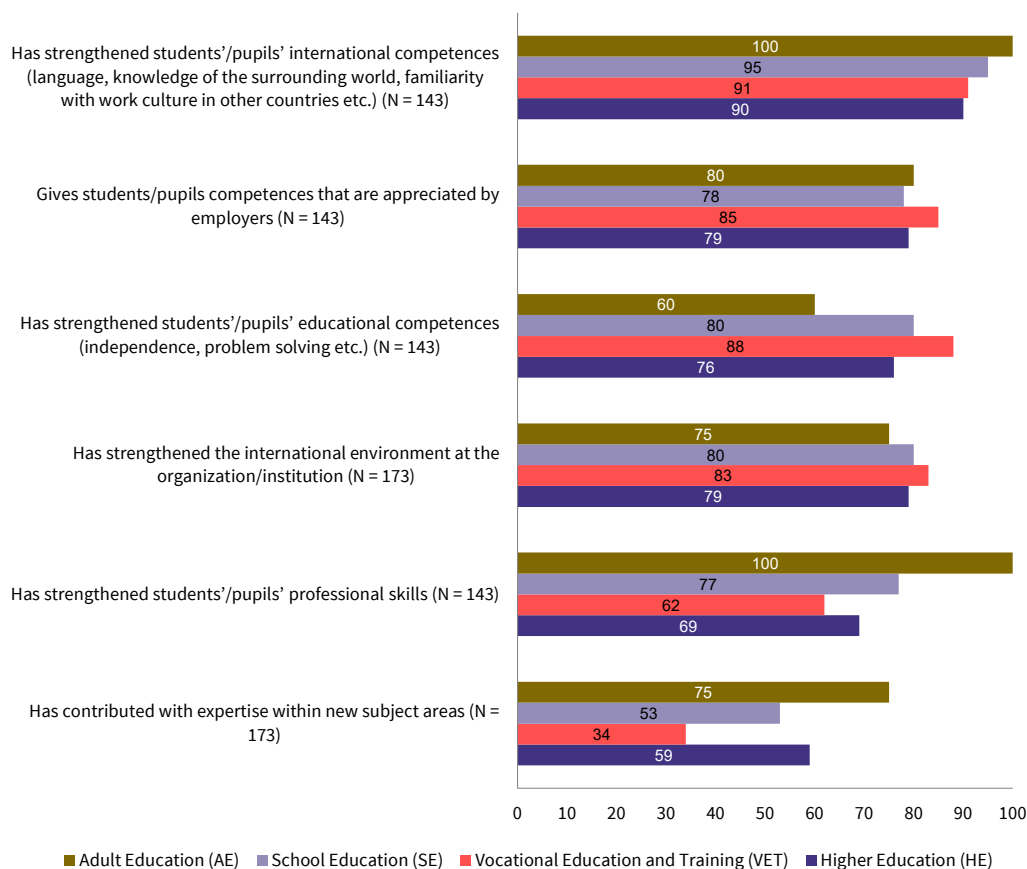

To what extent do you assess that Erasmus+...



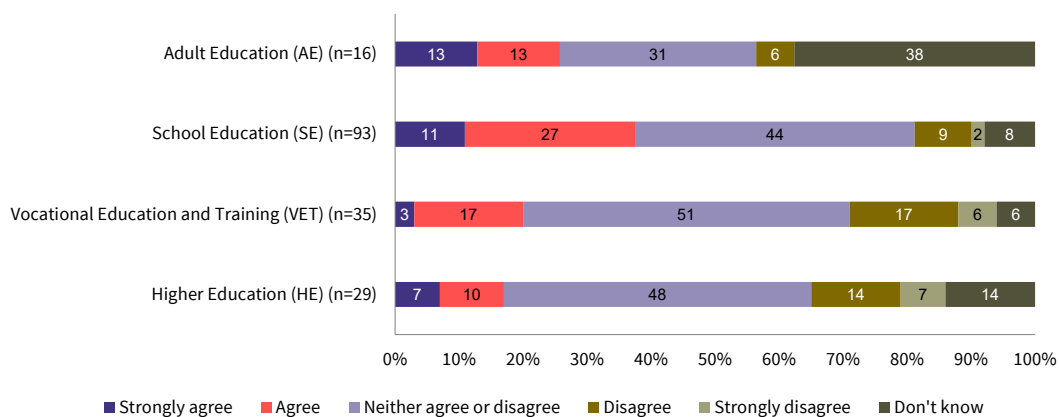

How much do you agree or disagree with the following statement: Our participation in Erasmus+ mobility activities supports the digital transformation of our educational programmes?



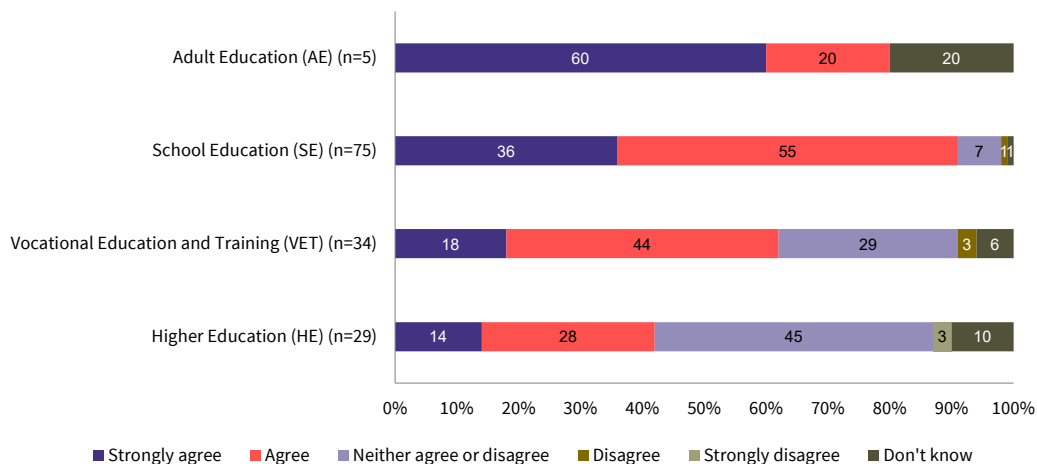

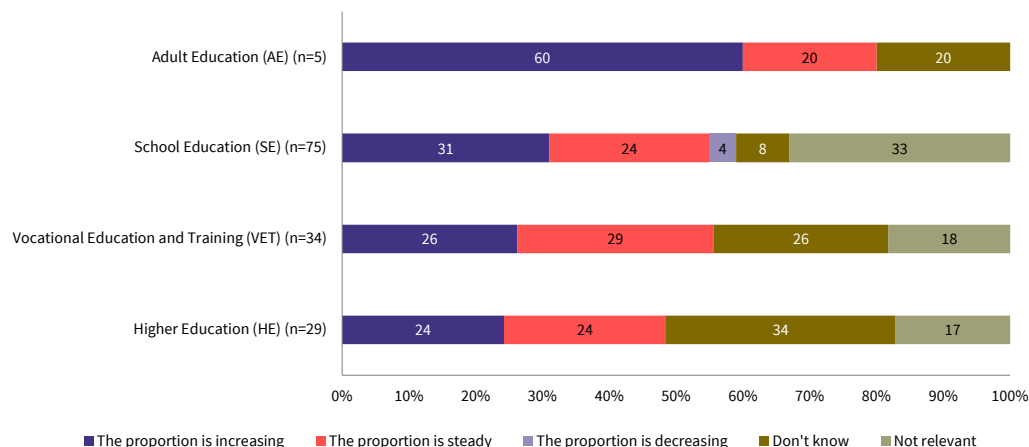

What is the development in the proportion of hard-to-reach groups that you have managed to send out through Erasmus+?



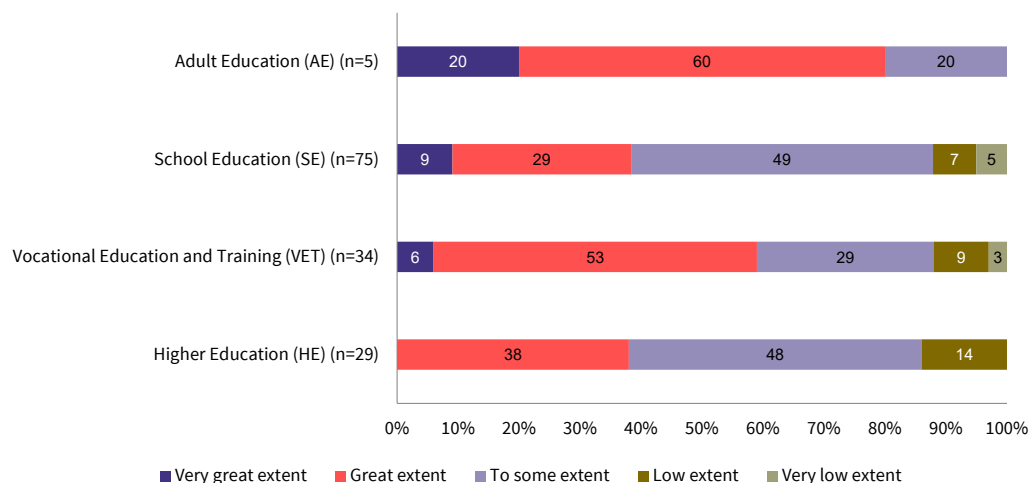

To what extent do you feel that, nationally, there has been an increased focus on sending hard-to-reach groups on mobility stays through Erasmus+?



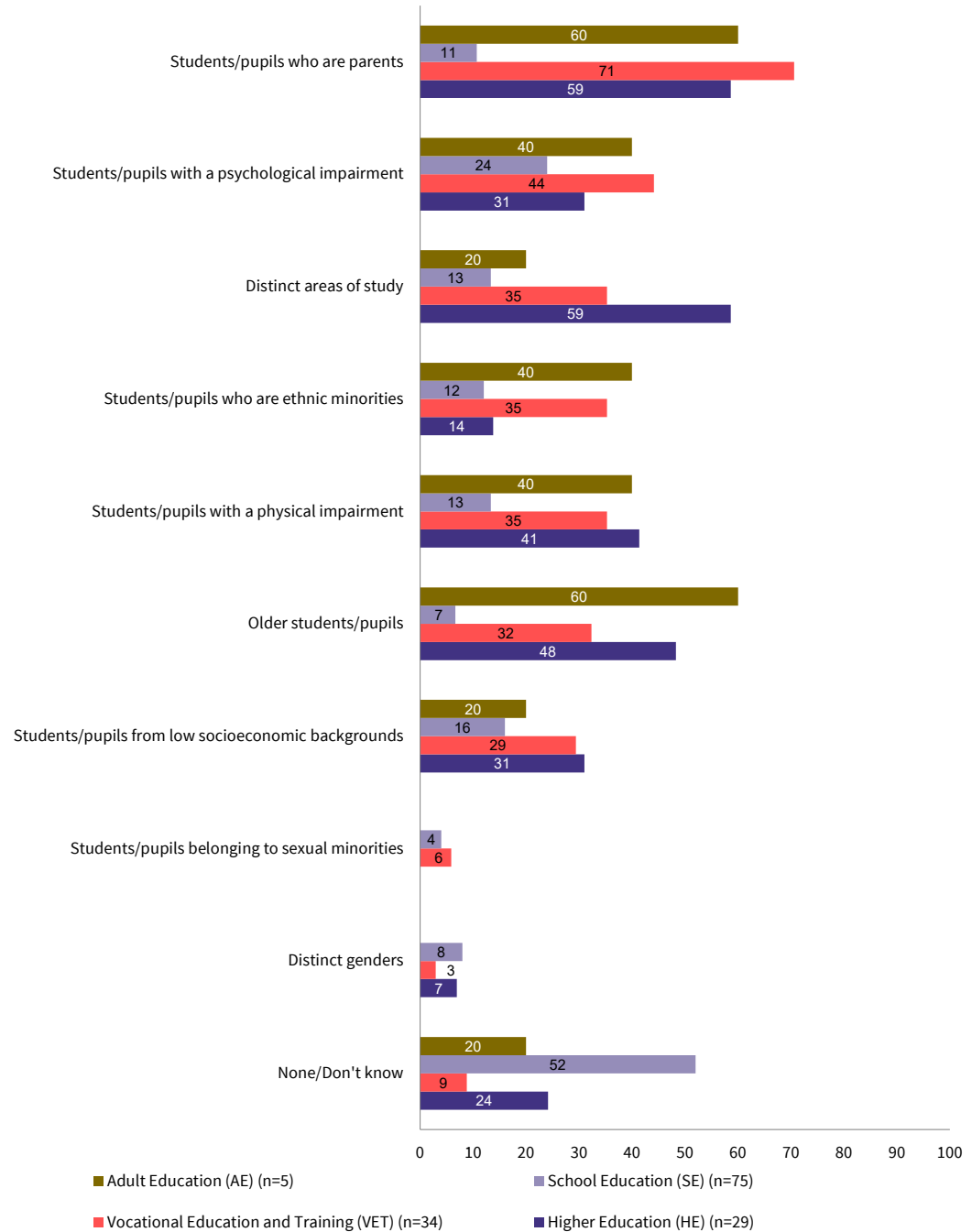

Which of the following are hard-to-reach groups among those sent abroad through Erasmus+ at your institution?



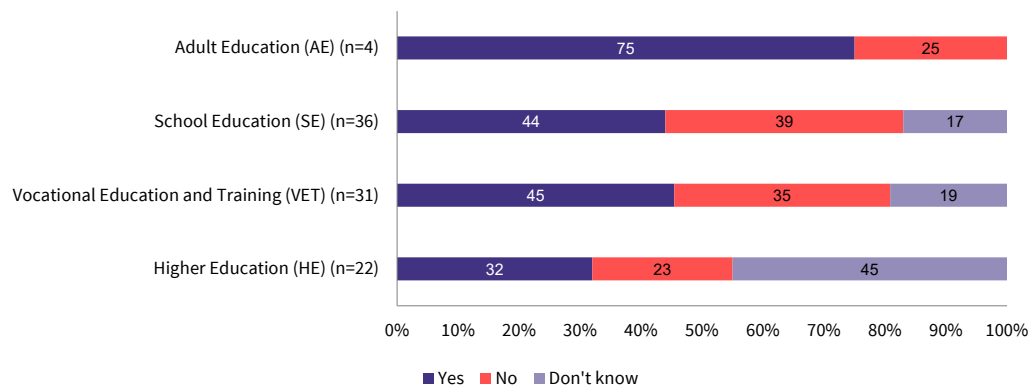

Does your hard-to-reach group/groups match those that can receive "fewer opportunities top up" and/or "inclusion support"?



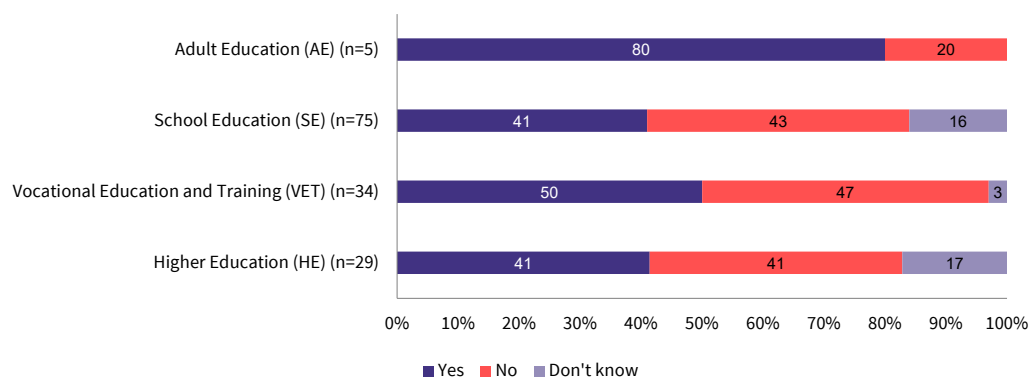

Do you have special measures in place to get your hard-to-reach students/pupils sent out through Erasmus+?



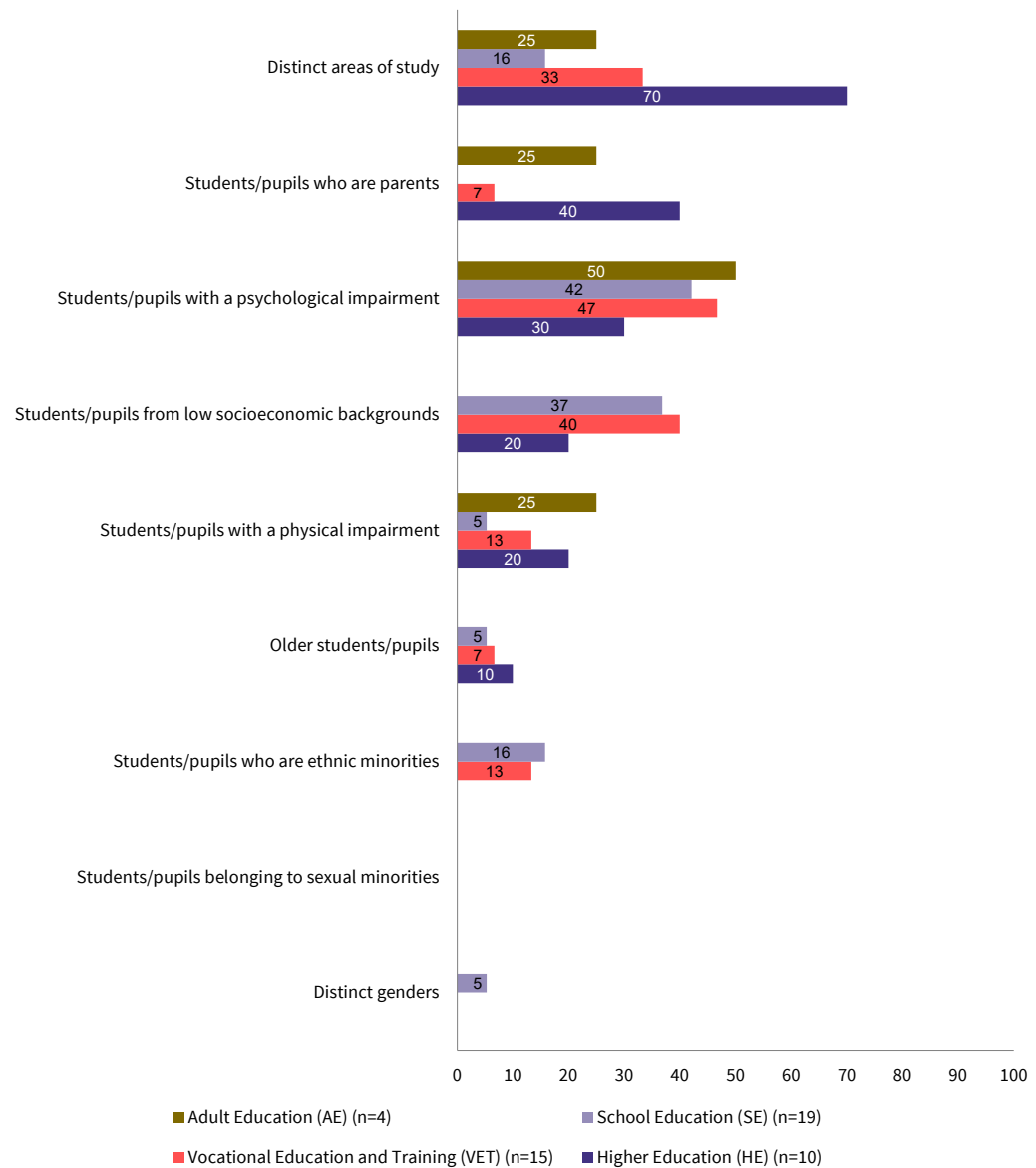

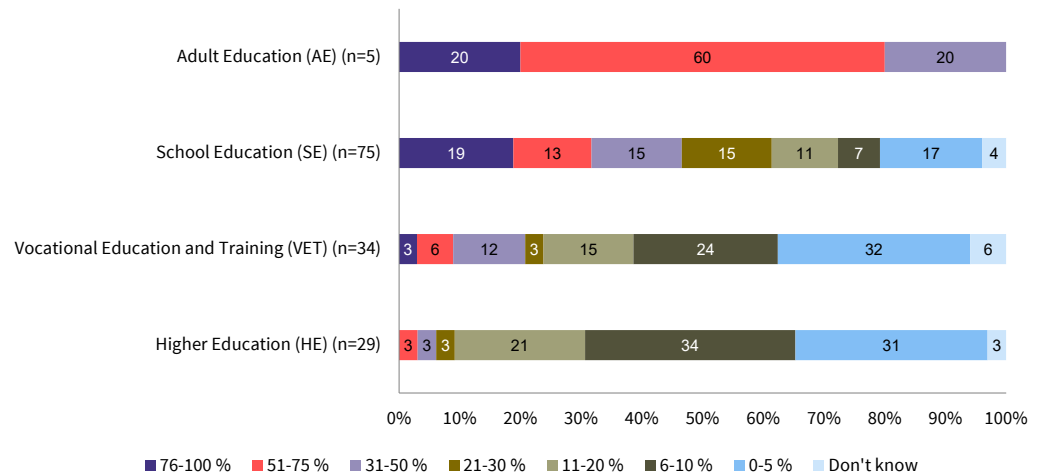

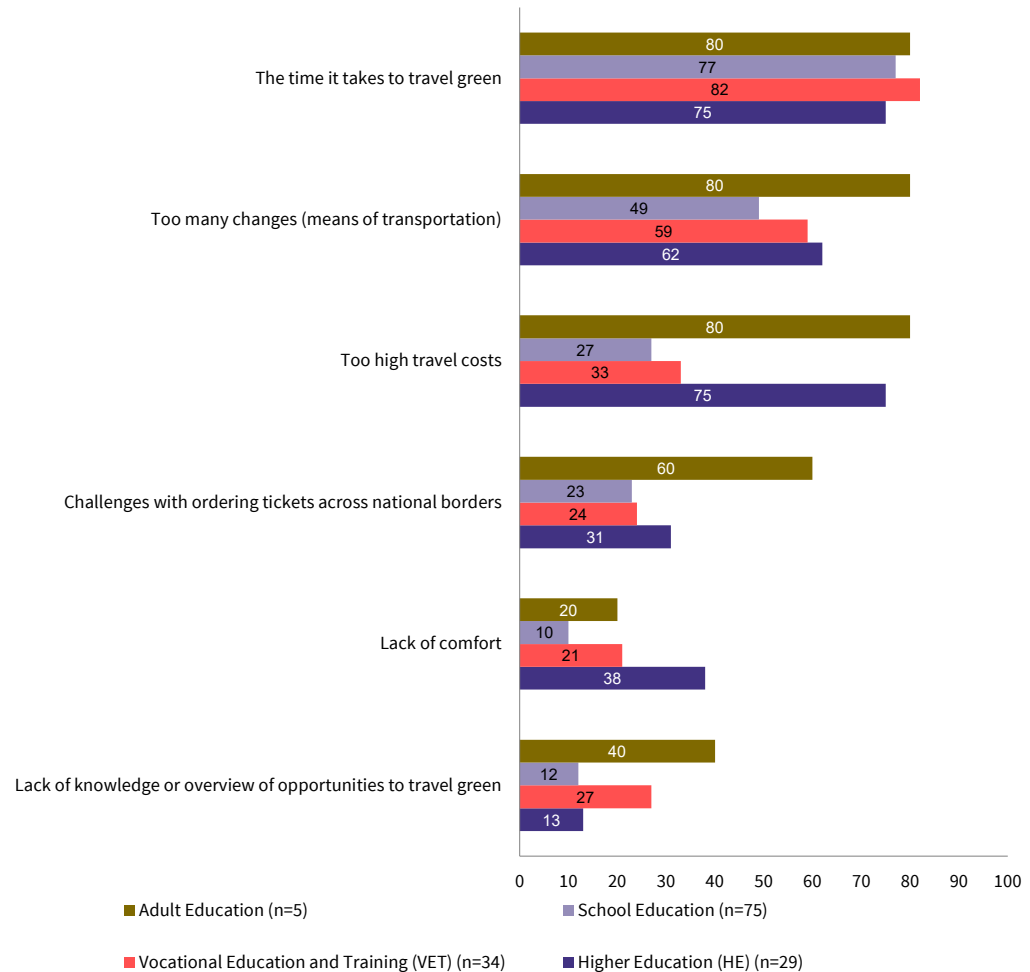

To what extent do you assess that the following scenarios constitute barriers to having more students/pupils use green forms of transportation when travelling to their Erasmus+ destination?

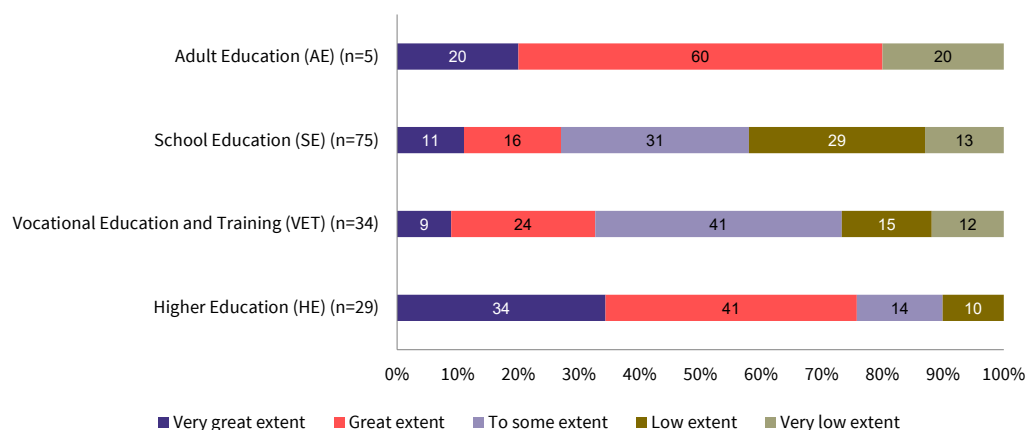

To what extent do you assess that too high travel costs constitute a barrier to having more students/pupils use green forms of transportation when travelling to their Erasmus+ destination?



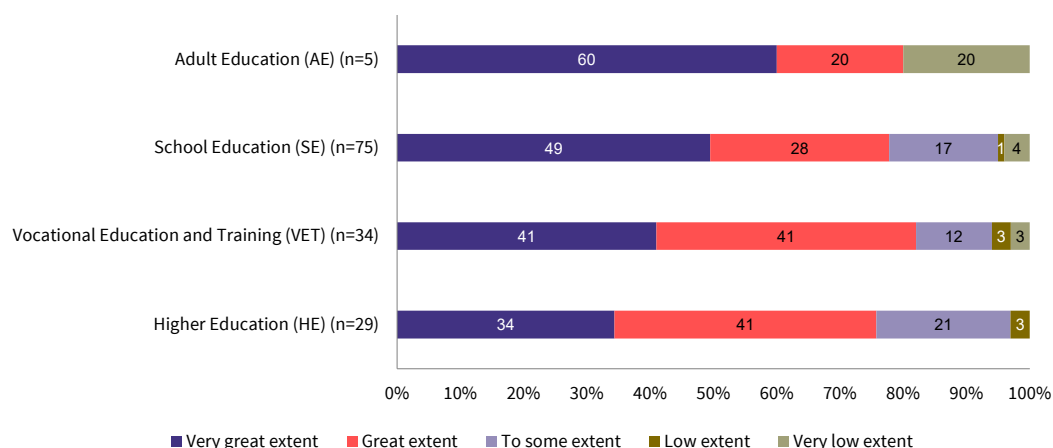

To what extent do you assess that the time it takes to travel green constitutes a barrier to having more students/pupils use green forms of transportation when travelling to their Erasmus+ destination?



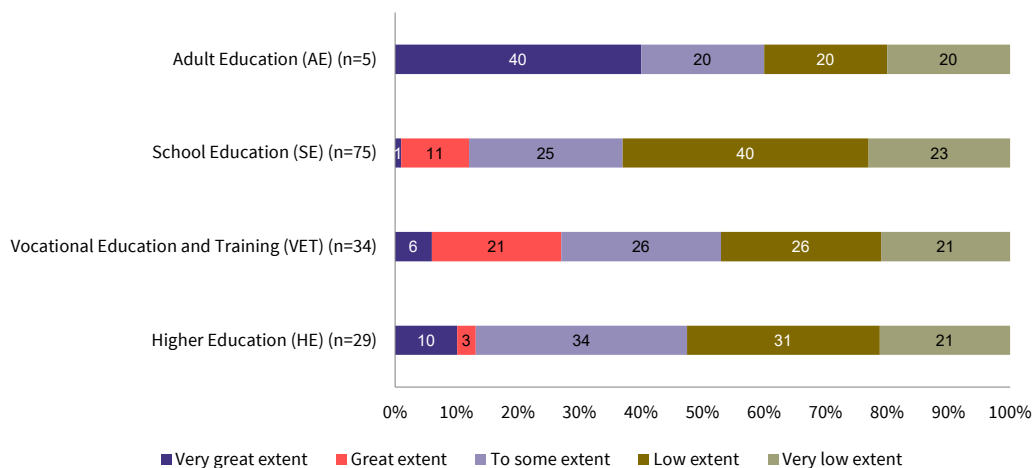

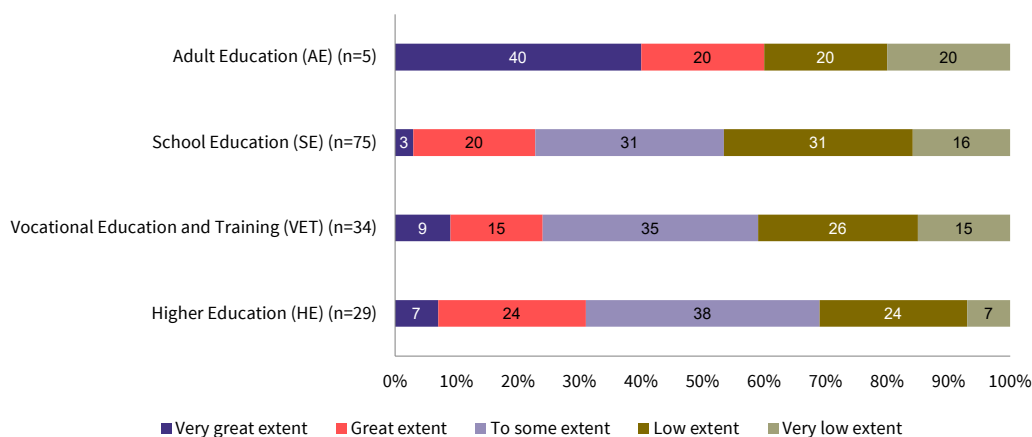

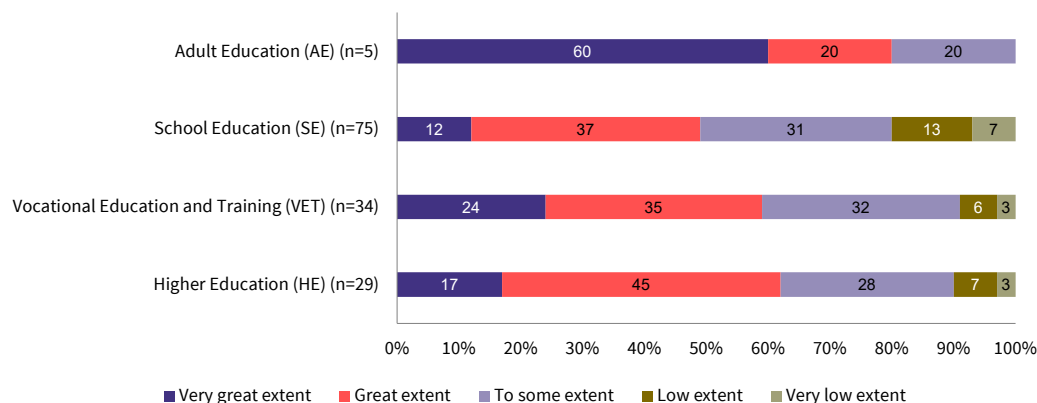

To what extent do you assess that too many transport changes constitute a barrier to having more students/pupils use green forms of transportation when travelling to their Erasmus+ destination?



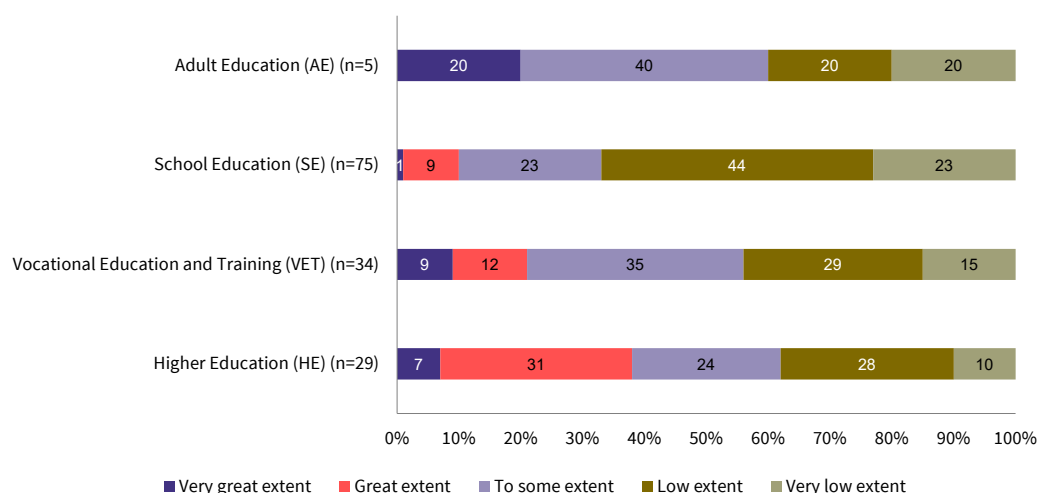

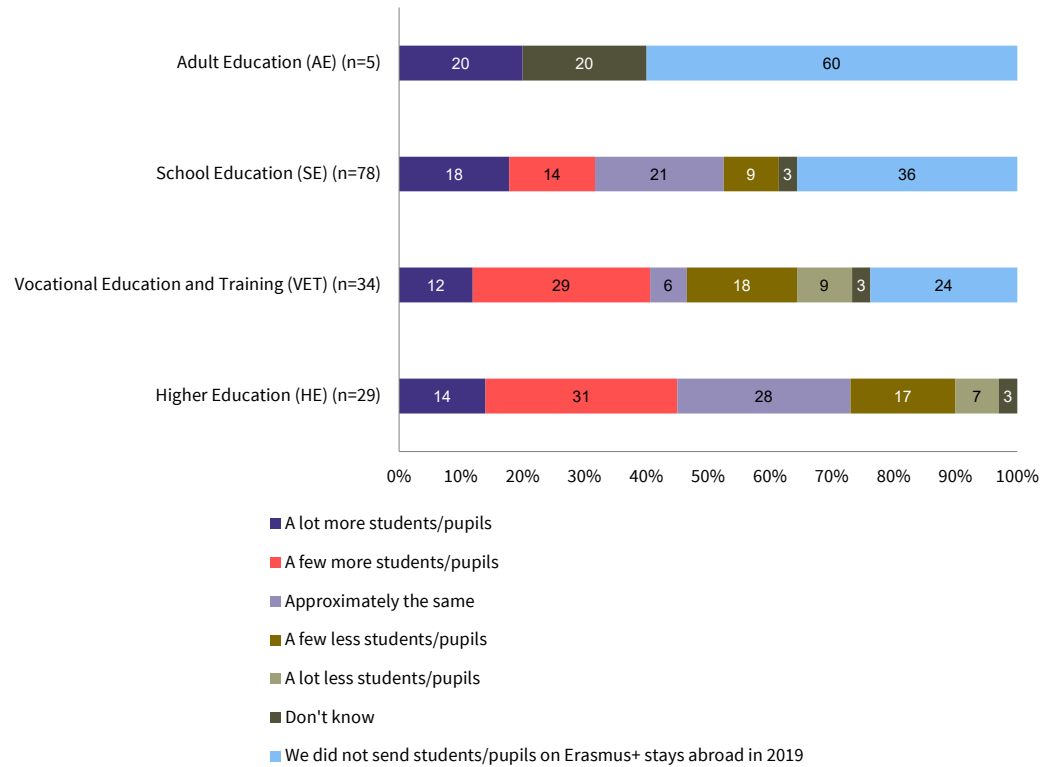

Is the number of your students going on Erasmus+ mobility stays abroad at the same level as in 2019 (before covid-19)?



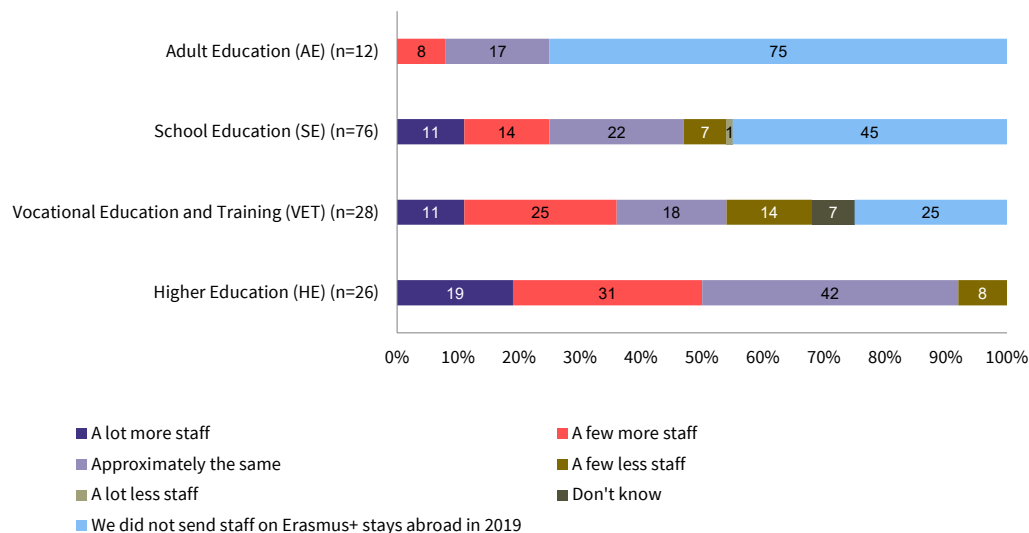

Is the number of staff going on Erasmus+ mobility stays abroad at the same level as in 2019 (before covid-19)?



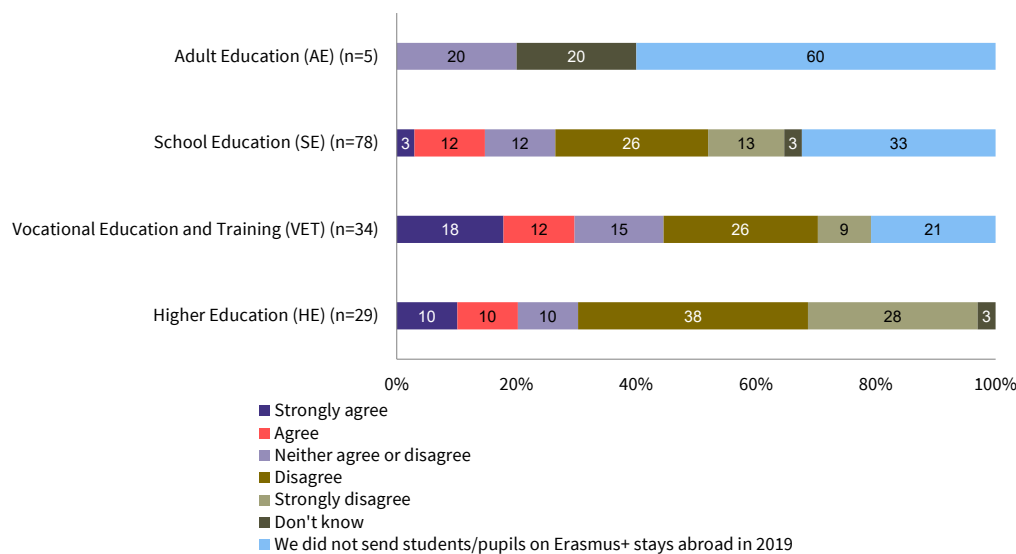

How much do you agree or disagree with the following statement: The covid-19 pandemic has meant that we have had to start all over again with building our Erasmus+ network to send out students/pupils?



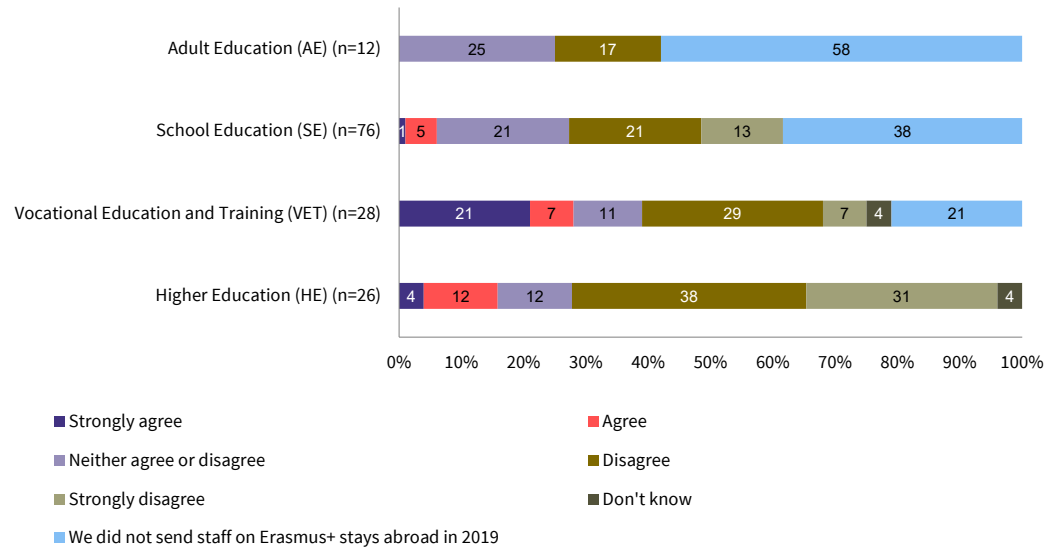

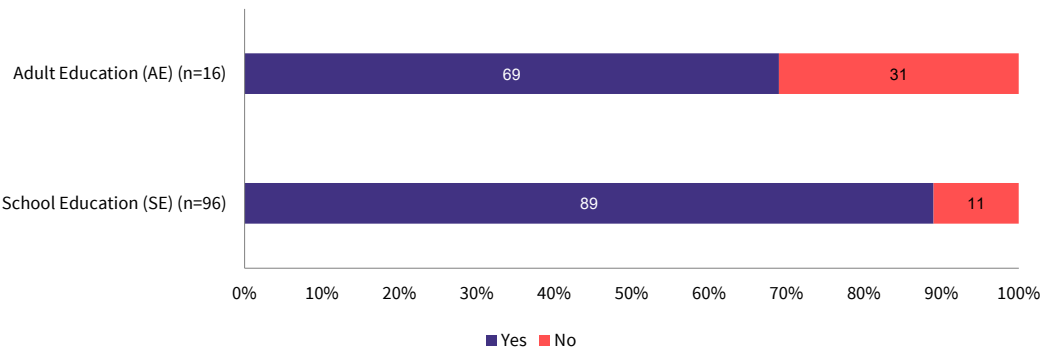

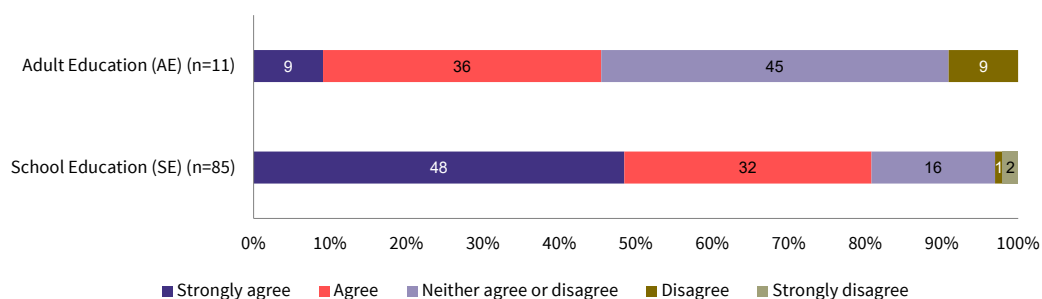

How much do you agree or disagree with the following statement: Accreditation has significantly decreased our time usage in the application process?



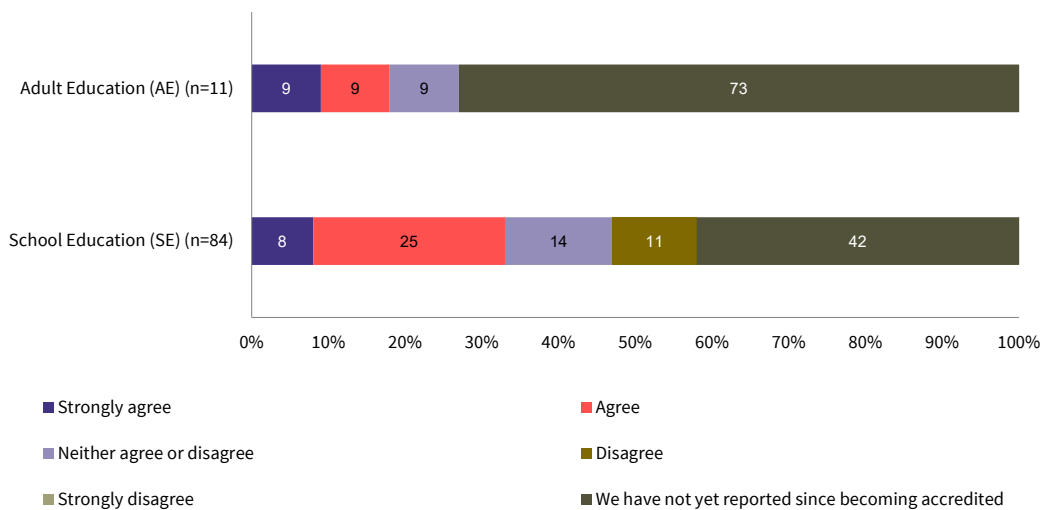

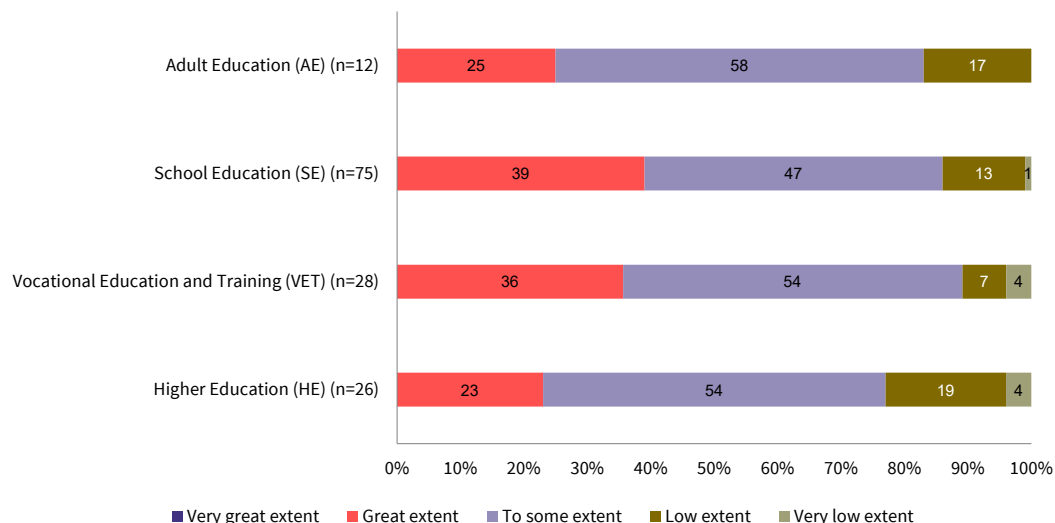

To what extent do you assess that the set unit cost rates cover the expenses associated with travel expenses for staff?



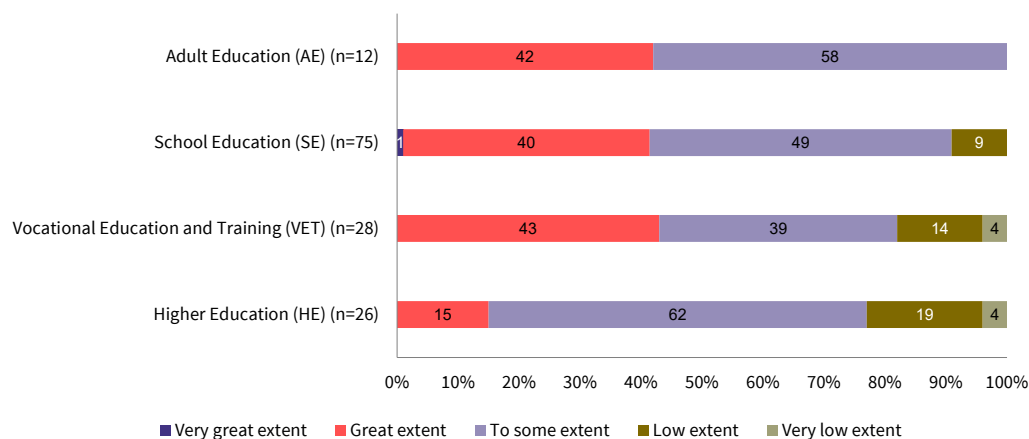

To what extent do you assess that the set unit cost rates cover the expenses associated with living costs for staff?



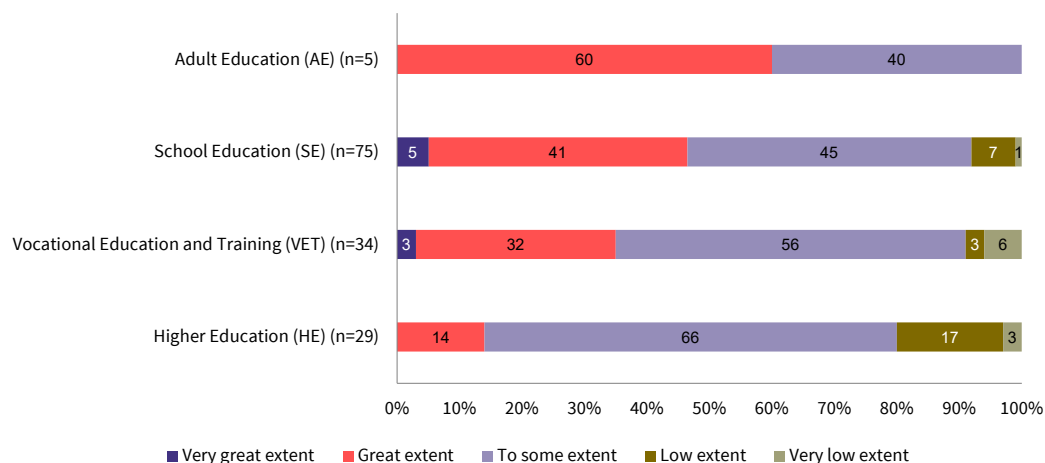

To what extent do you assess that the set unit cost rates cover the expenses associated with living costs for students/pupils?

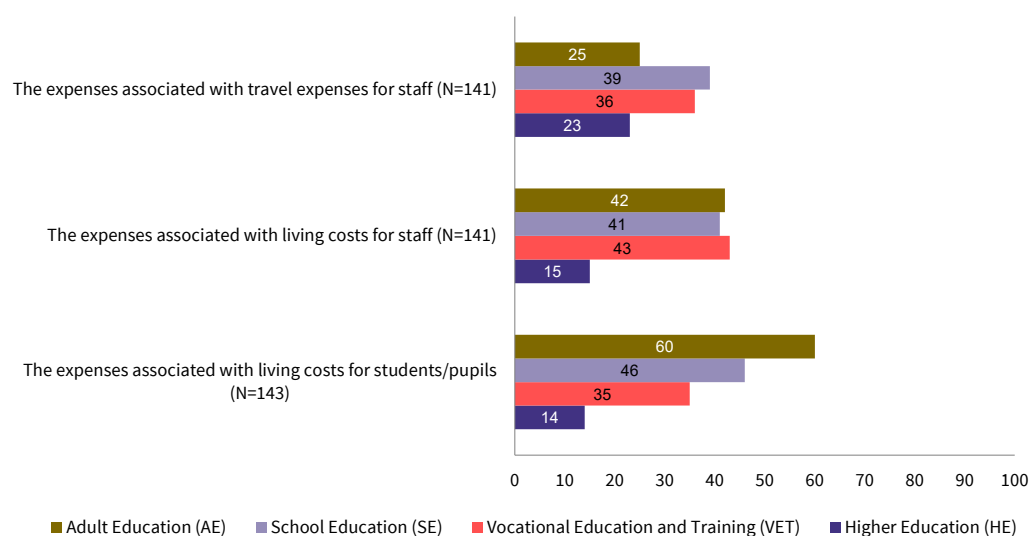

To what extent do you assess that the set unit cost rates cover...

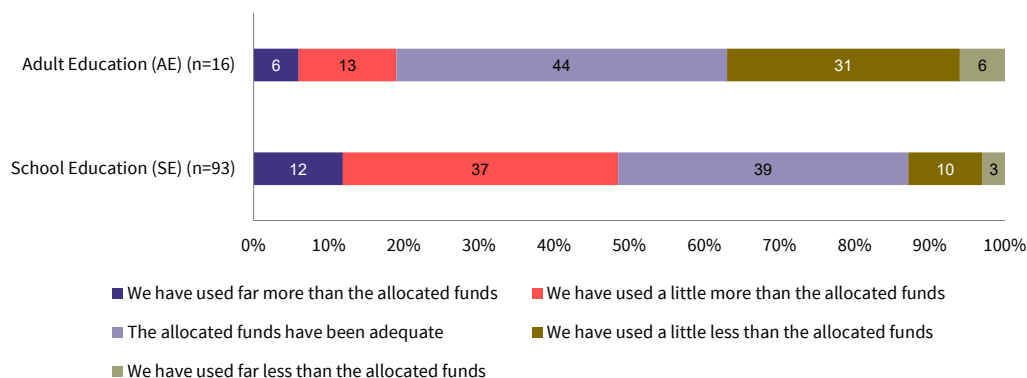

Has the institution experienced discrepancies between the allocated funds and the funds that are used?



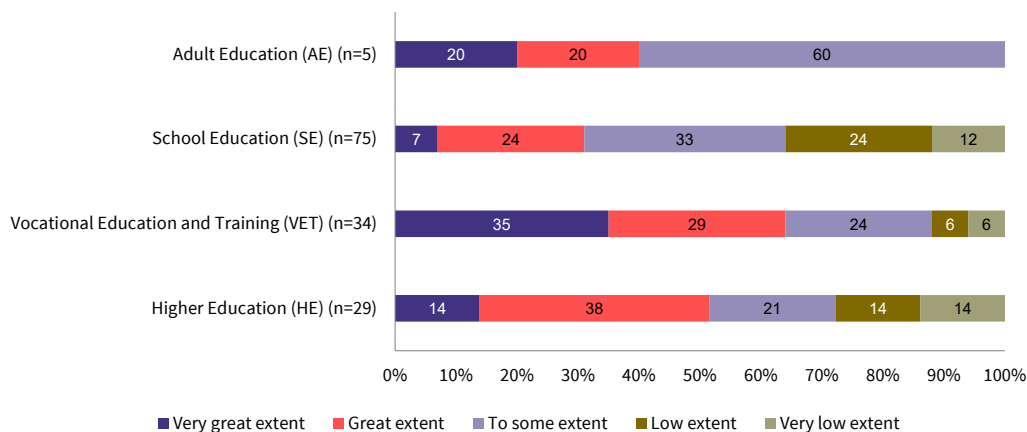

To what extent do you think that the following measures will get even more of your students/pupils sent out through Erasmus+: Better opportunities for students to travel abroad for a shorter period of time?



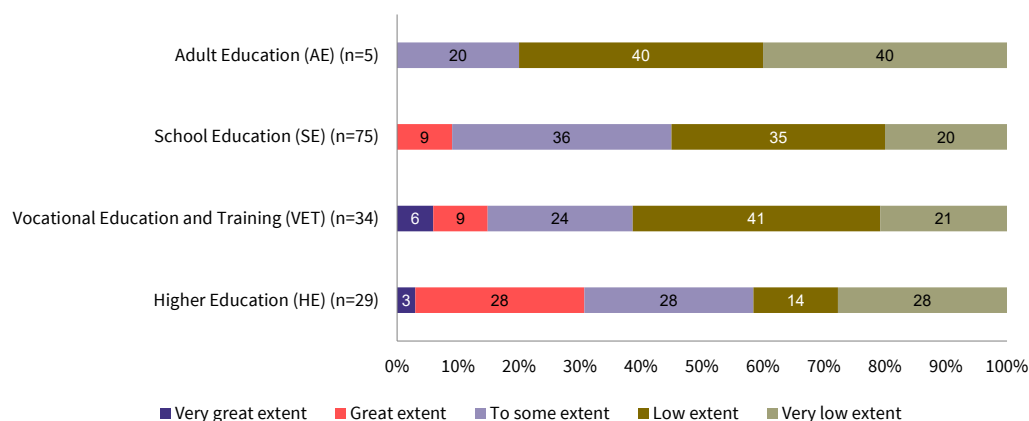

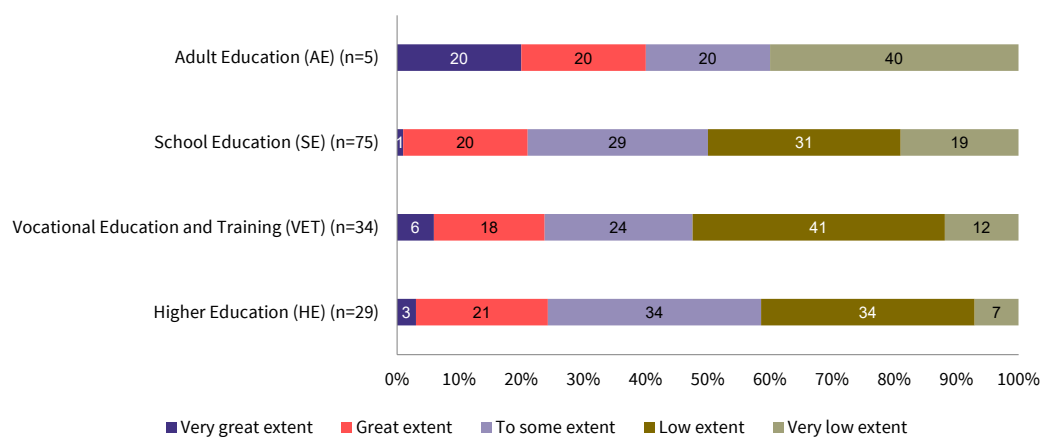

To what extent do you think that the following measures will get even more of your students/pupils sent out through Erasmus+: More destinations for students to choose between within the Erasmus+ countries?



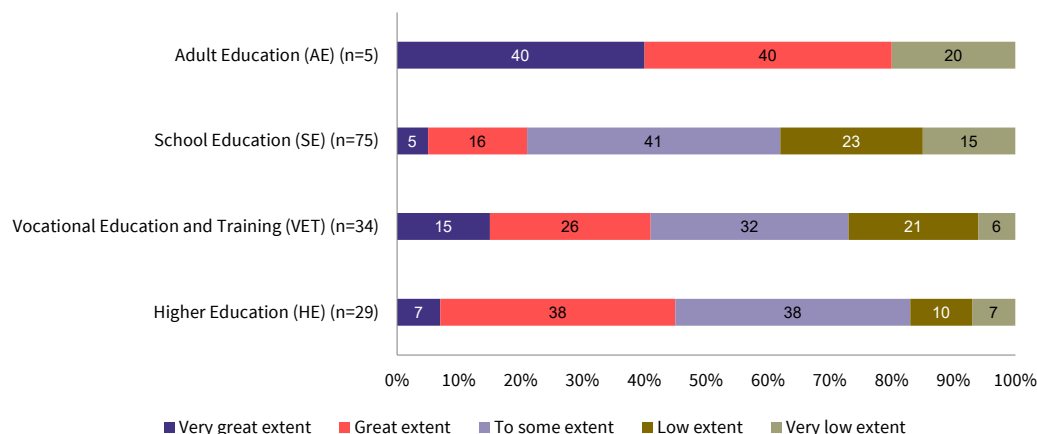

To what extent do you think that the following measures will get even more of your students/pupils sent out through Erasmus+: More destinations for students to choose between outside of the Erasmus+ countries?



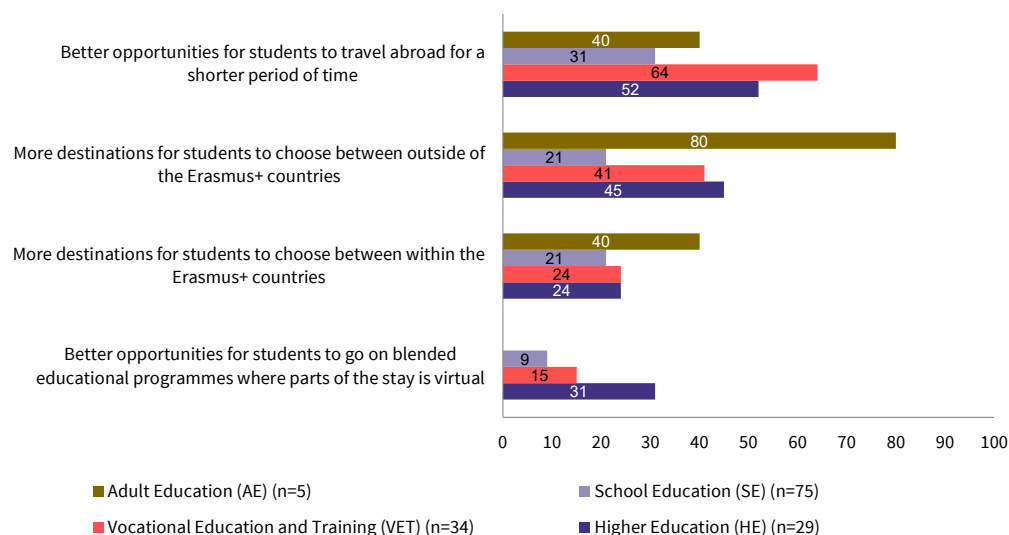

To what extent do you think that the following measures will get even more of your students/pupils sent out through Erasmus+...



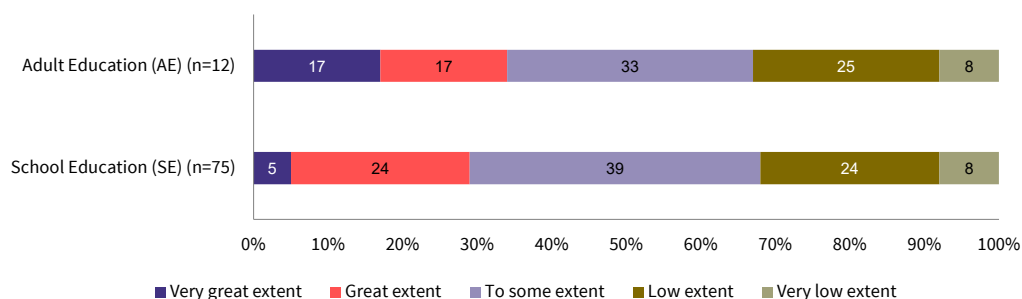

To what extent do you think that the following measures will get even more of your staff sent out through Erasmus+: Better opportunities for more flexibility in length of stays?

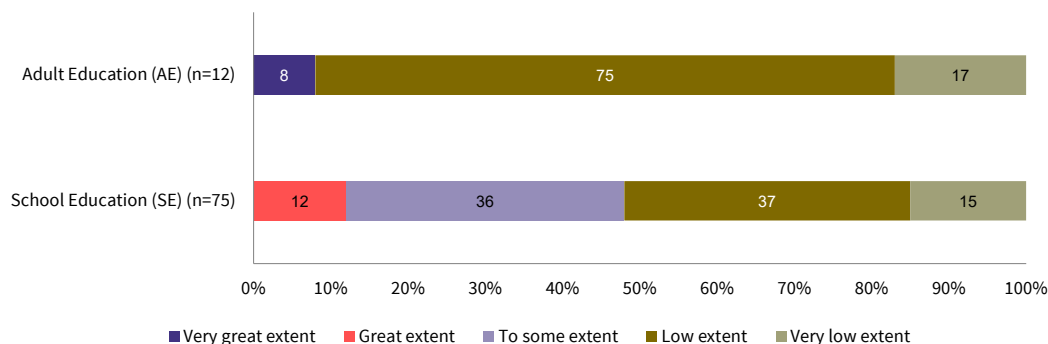

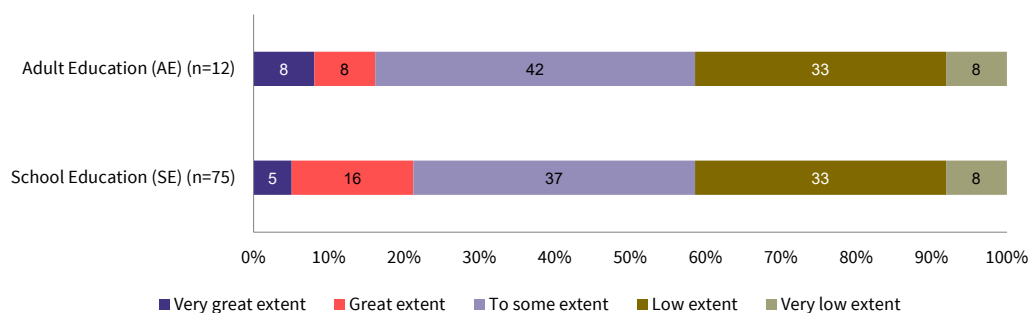

To what extent do you think that the following measures will get even more of your staff sent out through Erasmus+: More destinations for staff to choose between within the Erasmus+ countries?

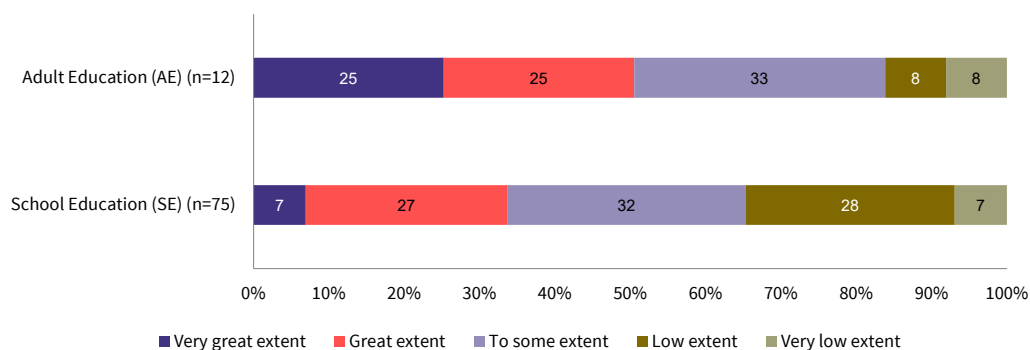

To what extent do you think that the following measures will get even more of your staff sent out through Erasmus+: More destinations for staff to choose between outside of the Erasmus+ countries?

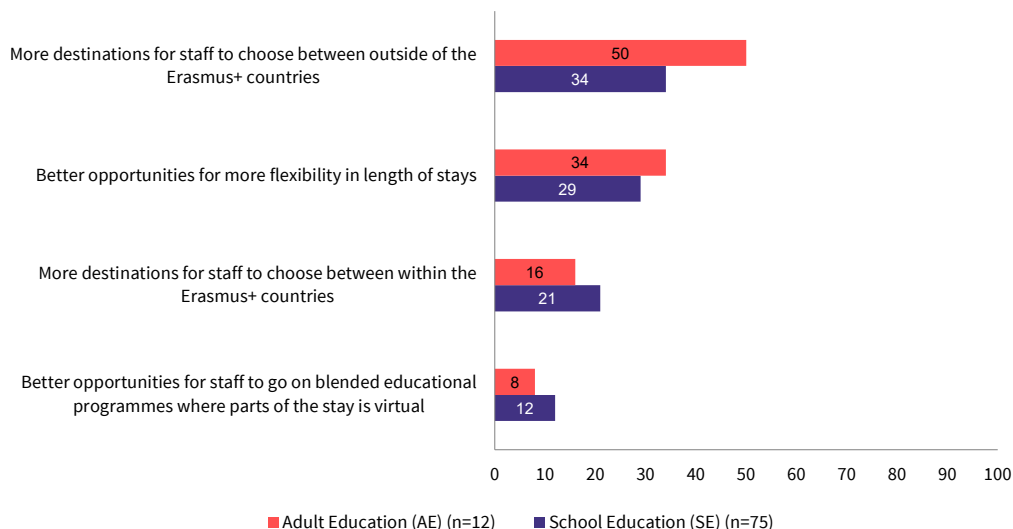

To what extent do you think that the following measures will get even more of your staff sent out through Erasmus+...

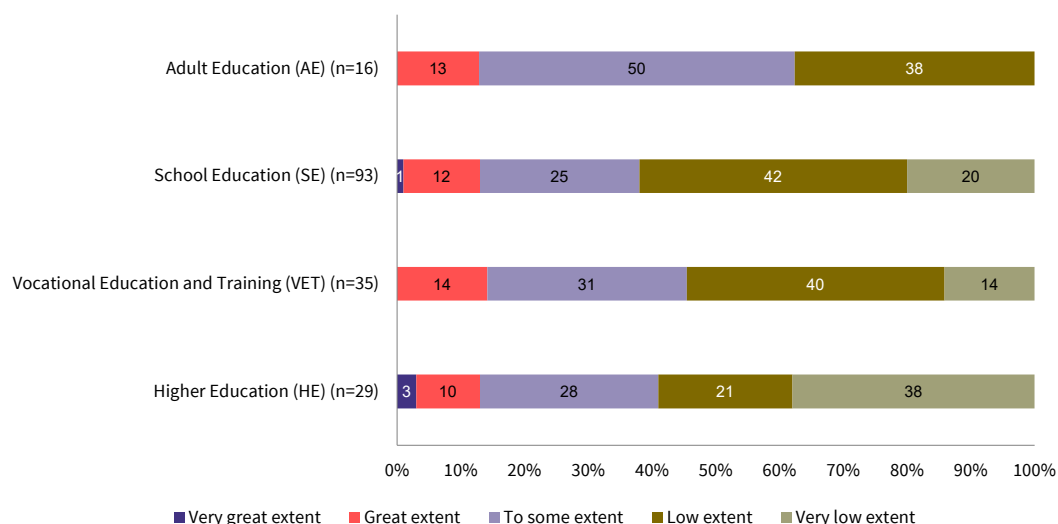

To what extent have you experienced challenges with identifying partners that can offer teaching with relevant content?



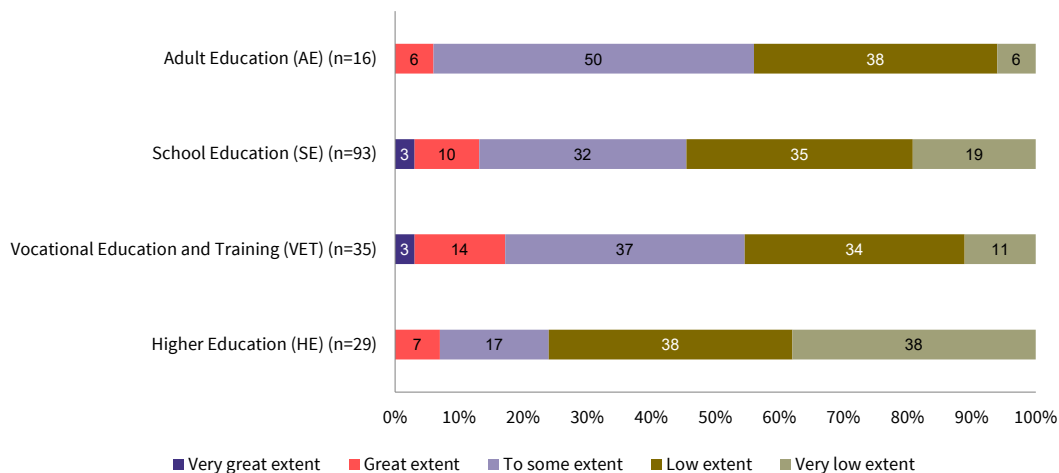

To what extent have you experienced challenges with identifying partners that can offer teaching of high quality regarding content?



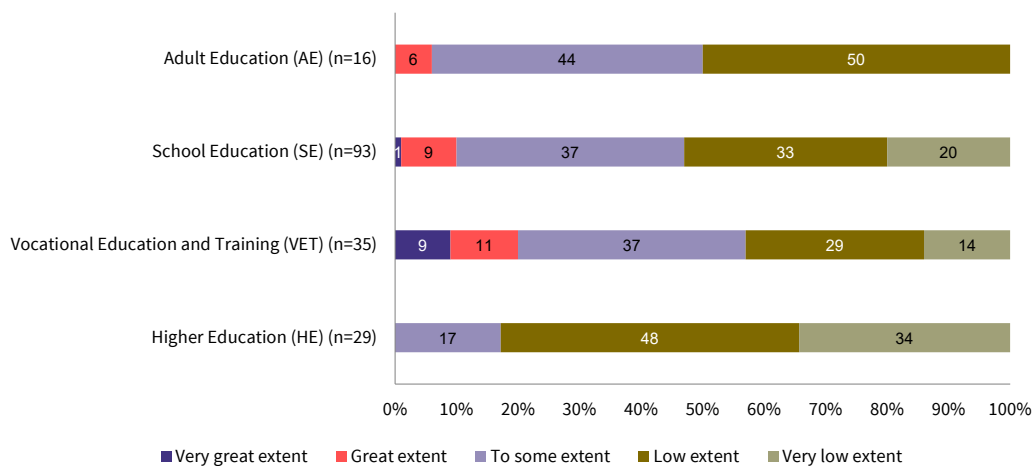

To what extent have you experienced challenges with identifying partners that can offer teaching based on relevant teaching methods?



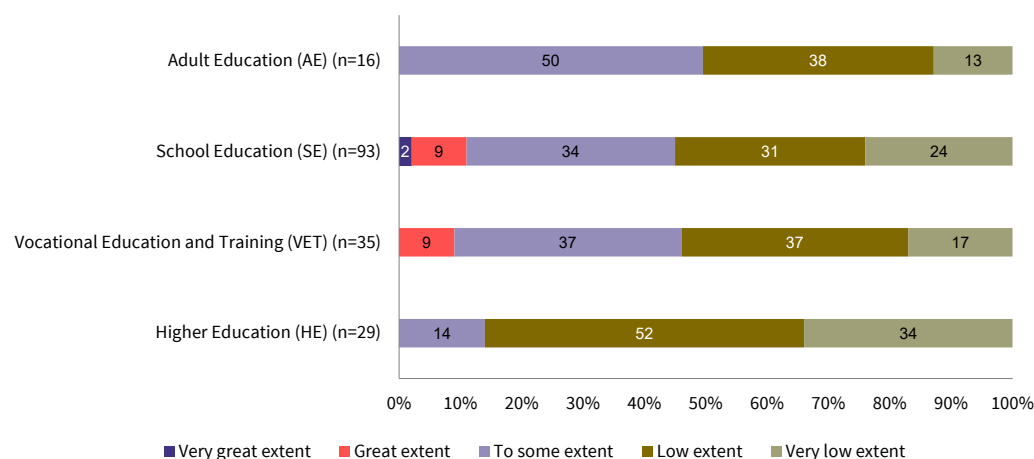

To what extent have you experienced challenges with identifying partners that can offer an inspiring professional environment for staff that are sent out?



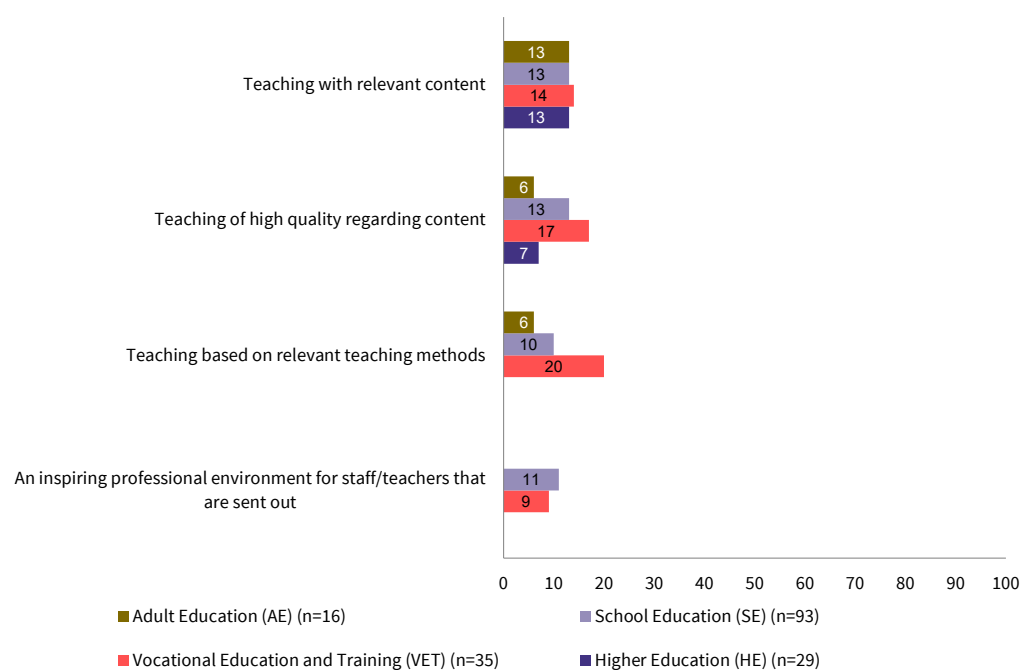

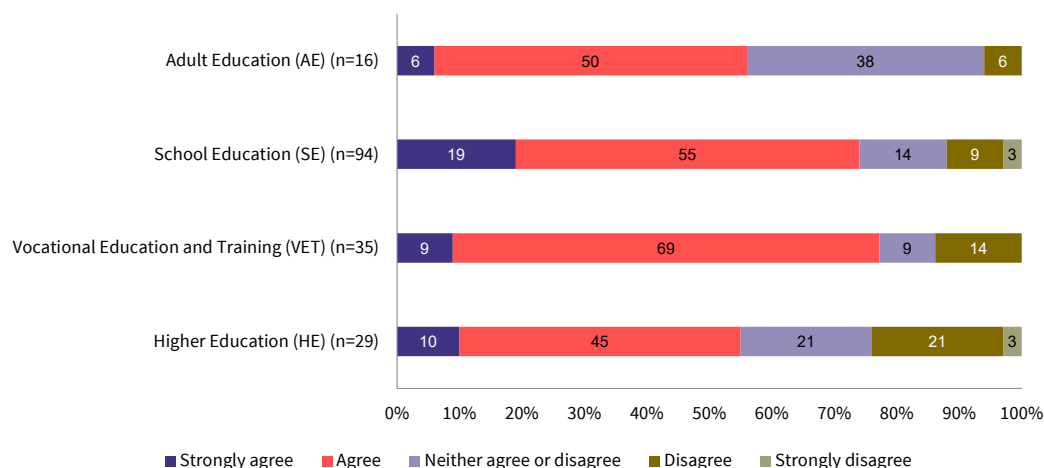

How much do you agree with the following statement: The application form is easy to understand and fill in based on the material provided by the European Commission and the Danish Agency for Higher Education and Science?



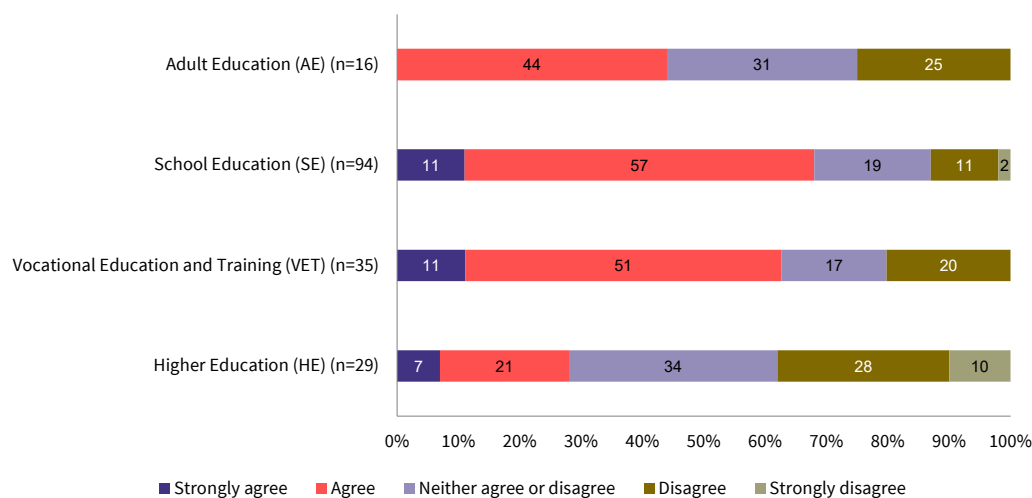

How much do you agree with the following statement: The contract is easy to understand and fill out based on the material provided by the European Commission and the Danish Agency for Higher Education and Science?



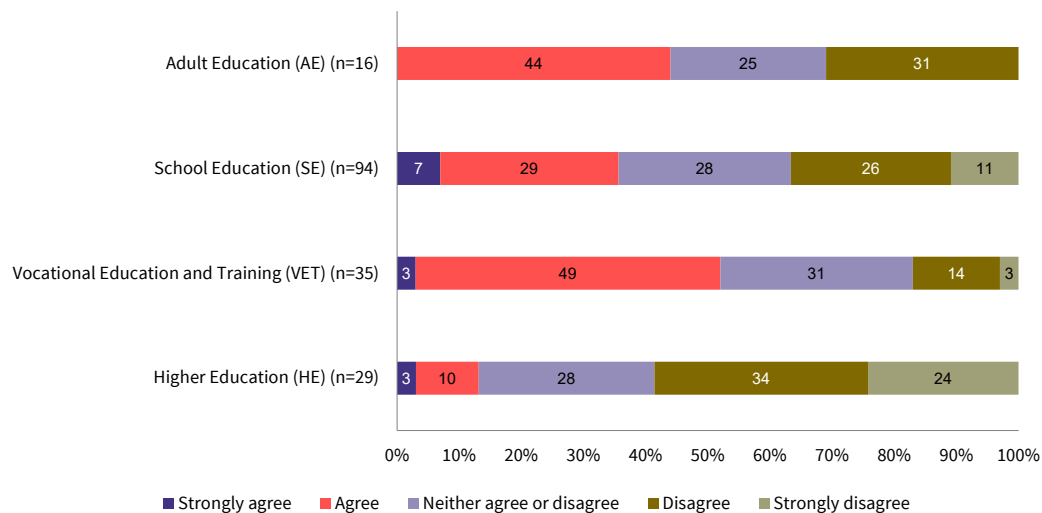

How much do you agree with the following statement: The programme guide is a clear, central document?



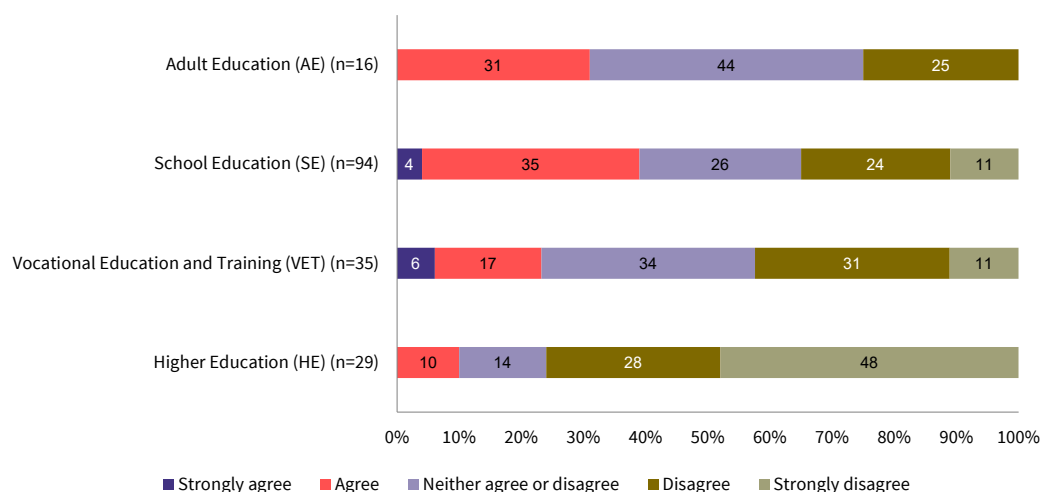

How much do you agree with the following statement: Beneficiary Module (BM) is user-friendly?



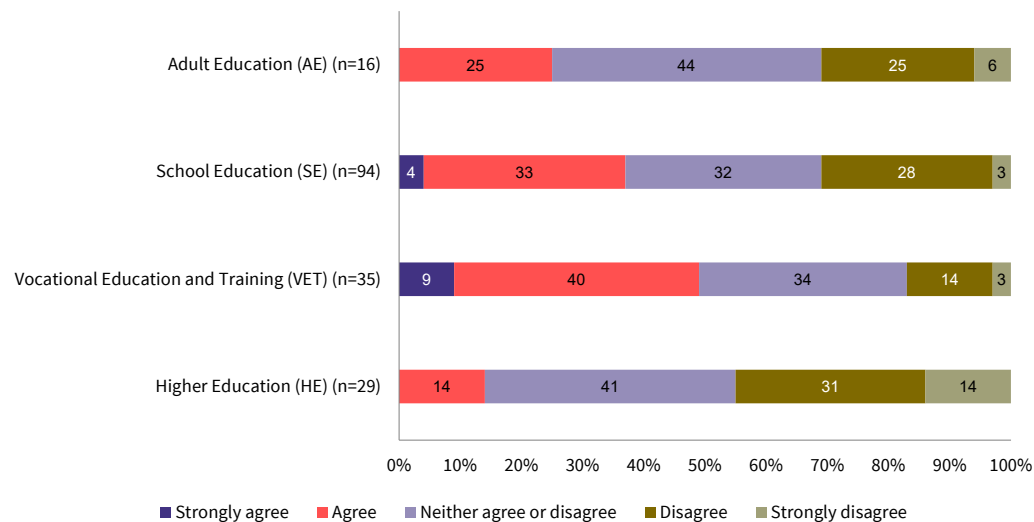

How much do you agree with the following statement: It is easy to find the necessary information material, such as guidelines?



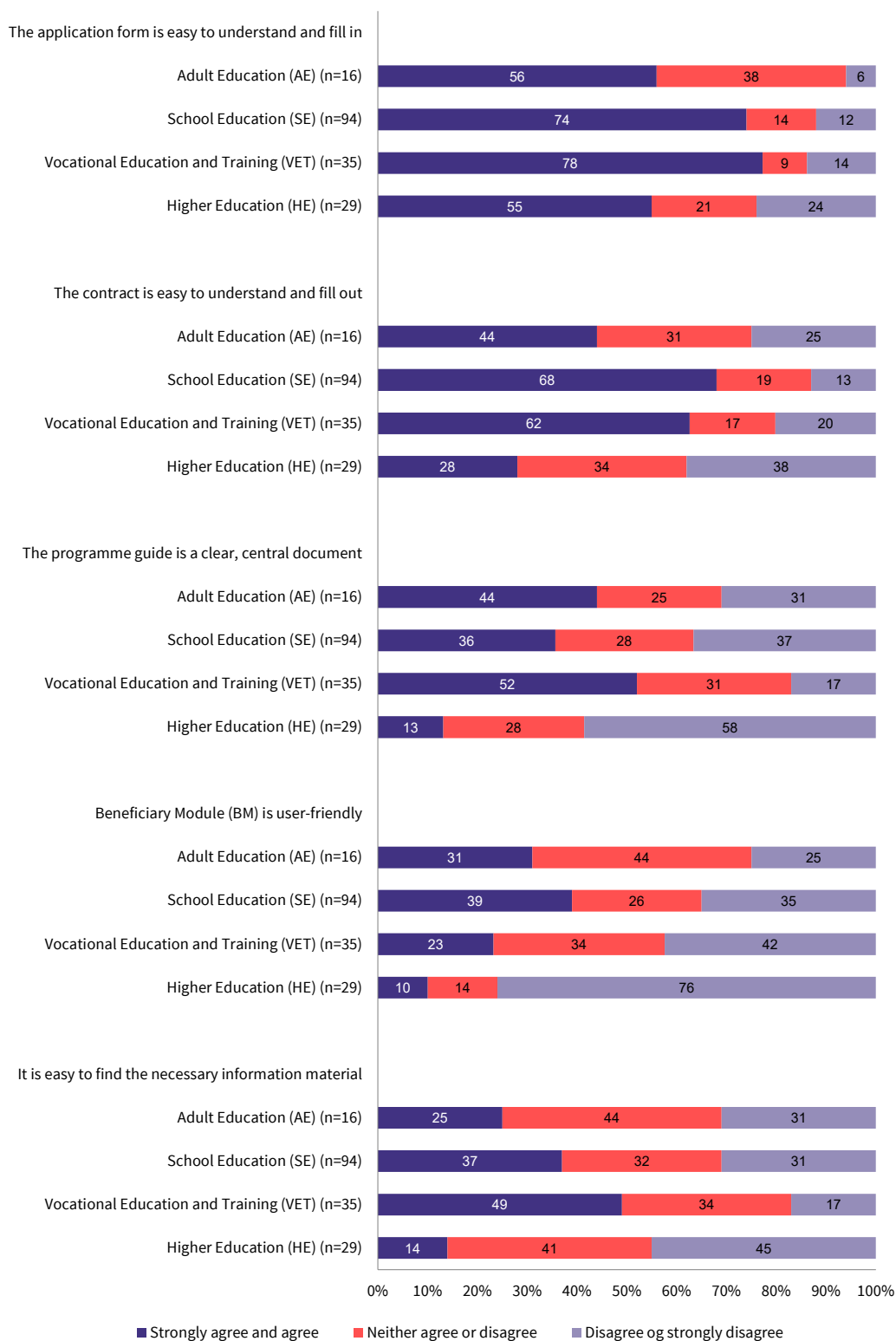

How much do you agree or disagree with the following statements...

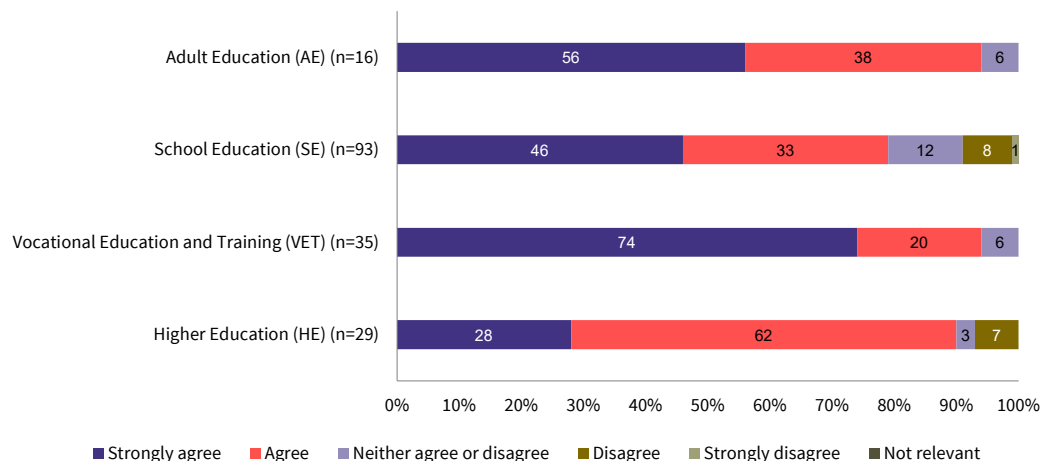

How much do you agree with the following statement: It is easy to get hold of relevant people in the National Agency?



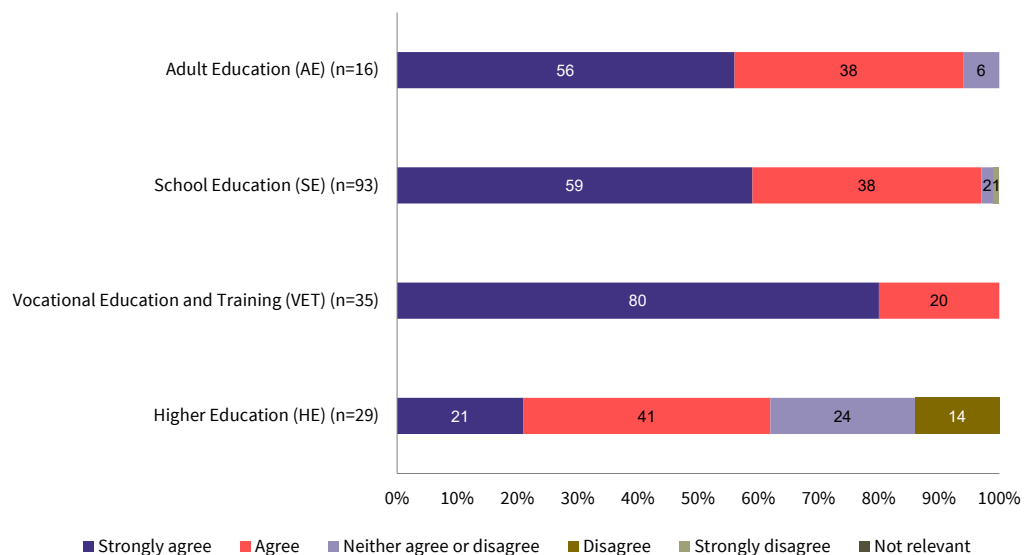

How much do you agree with the following statement: The National Agency can help us with the challenges we encounter?

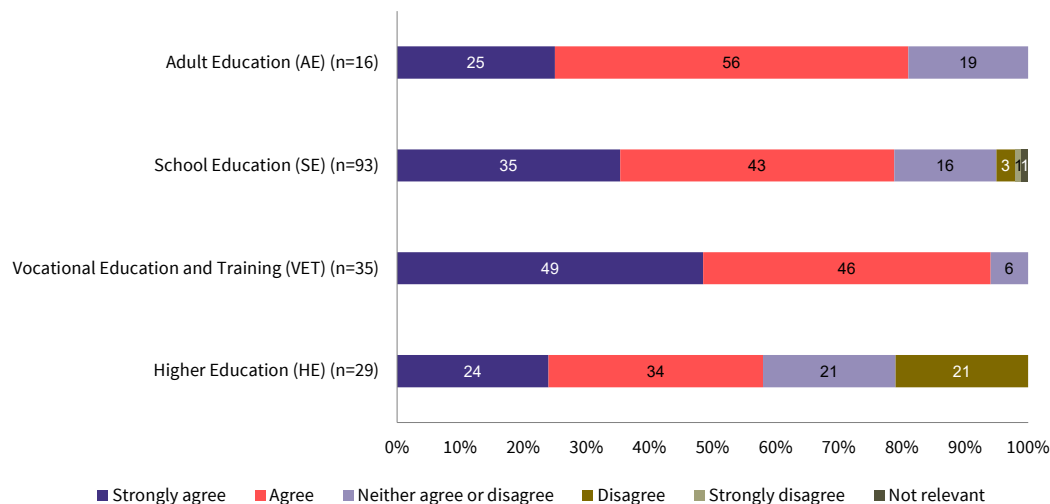

How much do you agree with the following statement: The written guidance material from the National Agency is a great help?



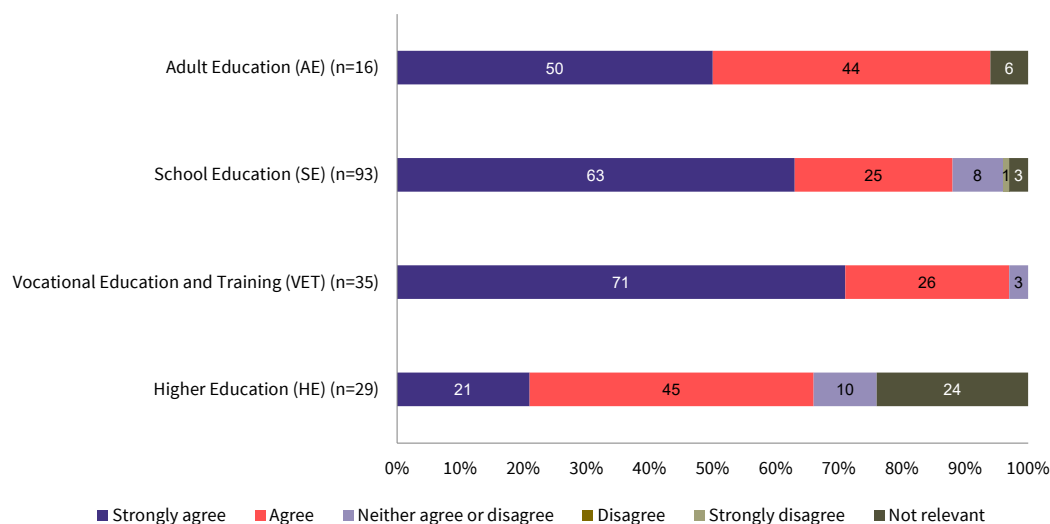

How much do you agree with the following statement: The start-up meetings for grant recipients held by the National Agency are a great help?

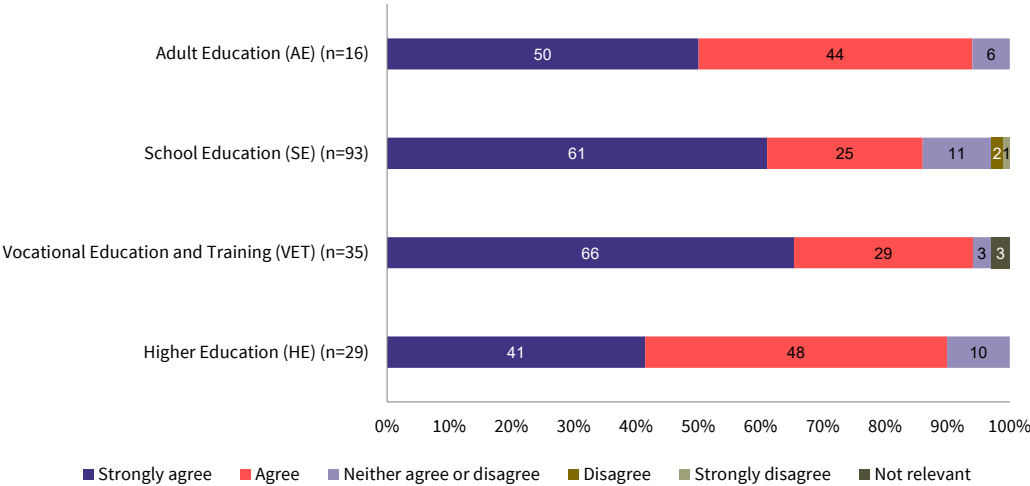

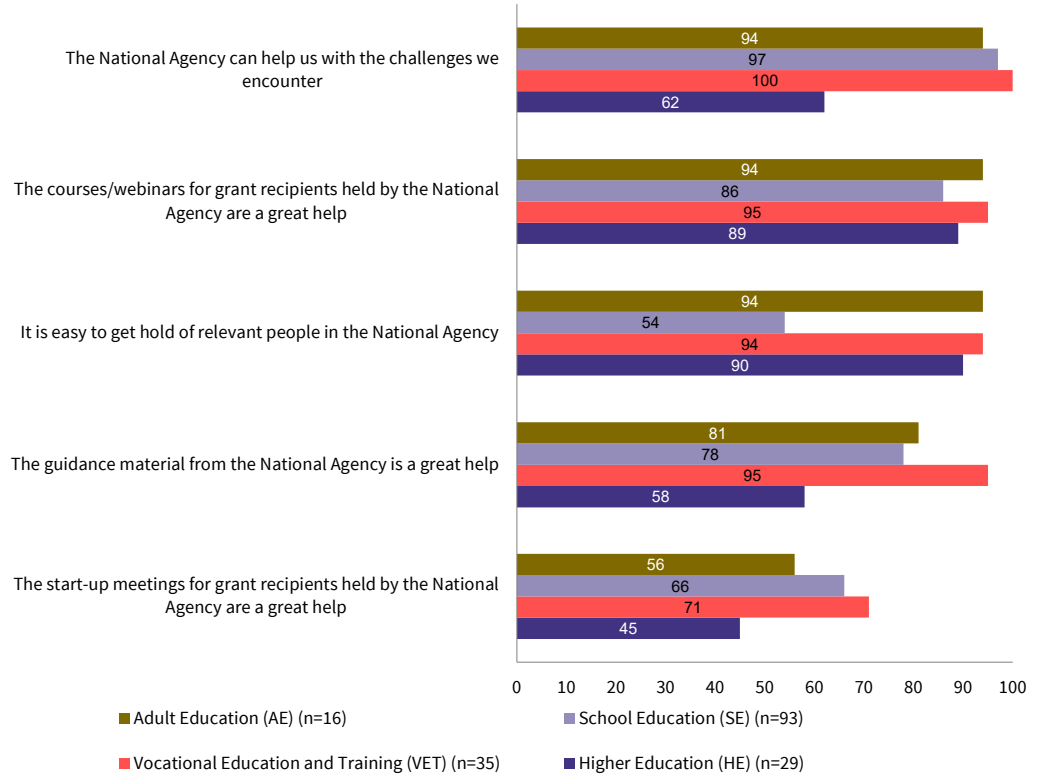

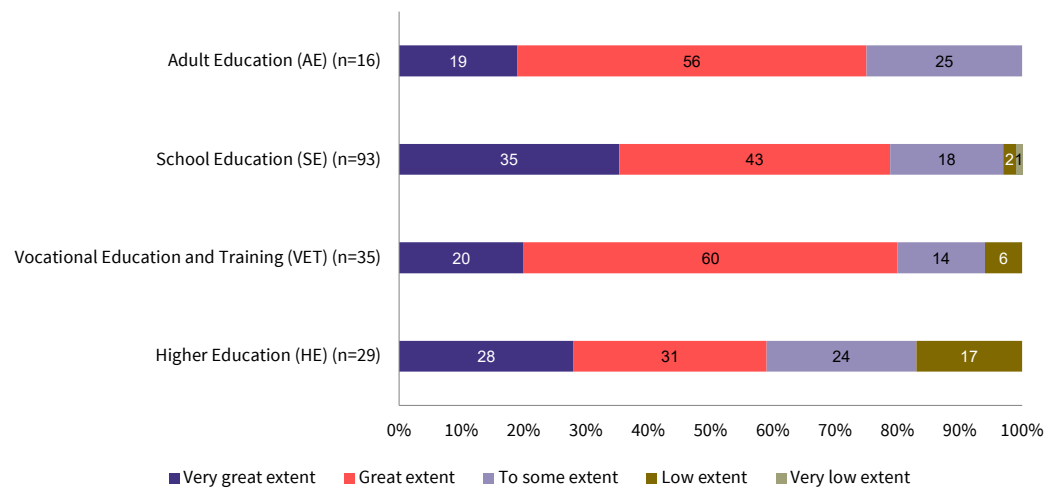

For how long has the institution/organisation participated in the Erasmus+ mobility programme?



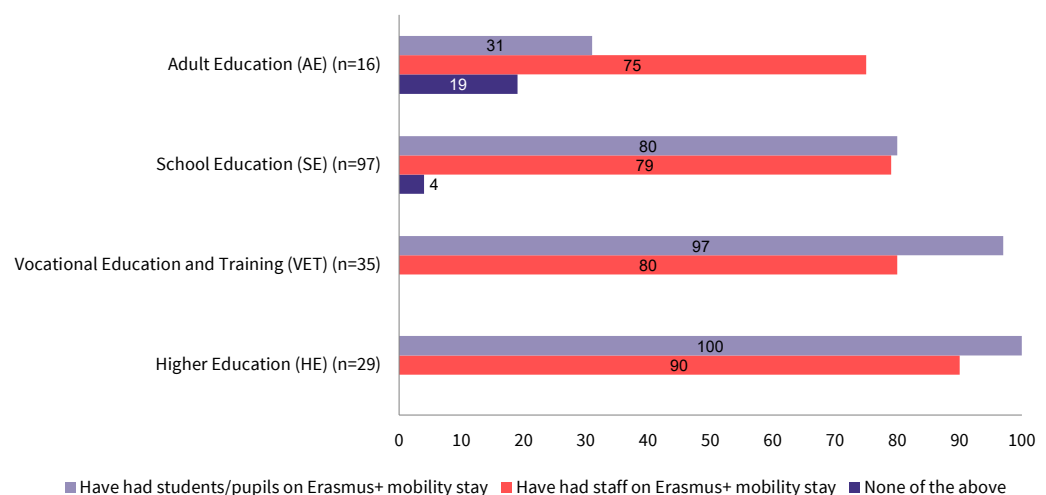

Which of the following parts of the mobility programme have you participated in during the current programme period (2021-2023)?



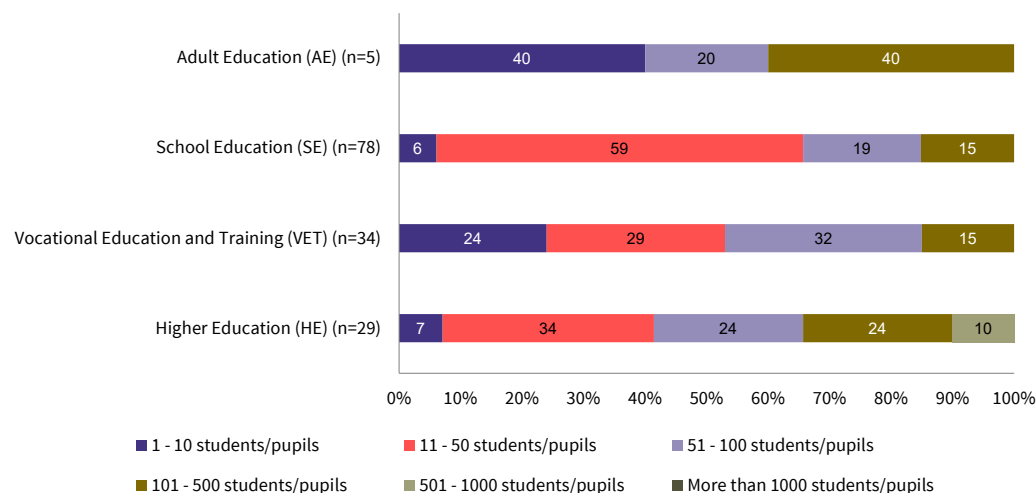

Approximately, how many of your students/pupils have participated in an Erasmus+ mobility stay in 2023?



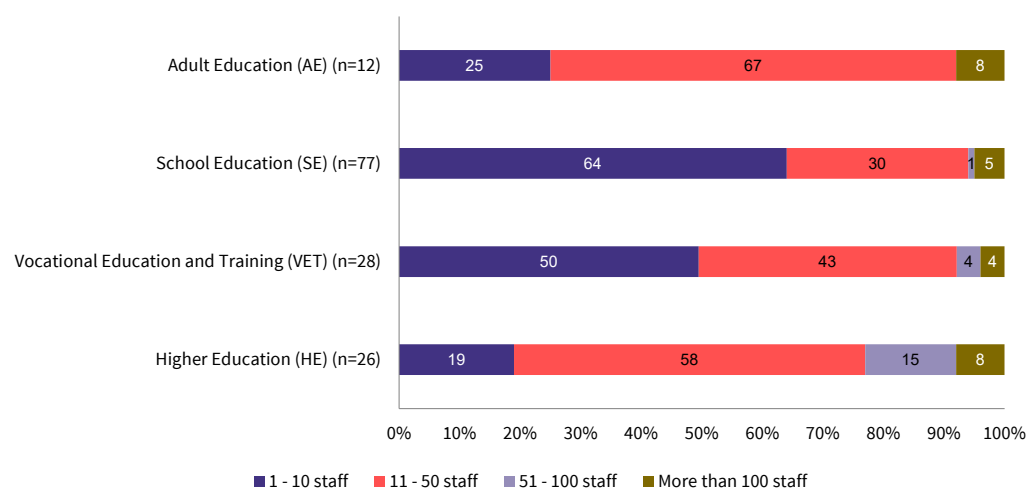
